

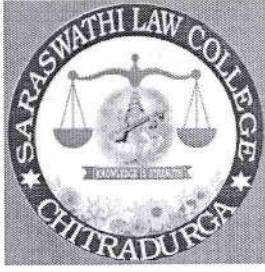

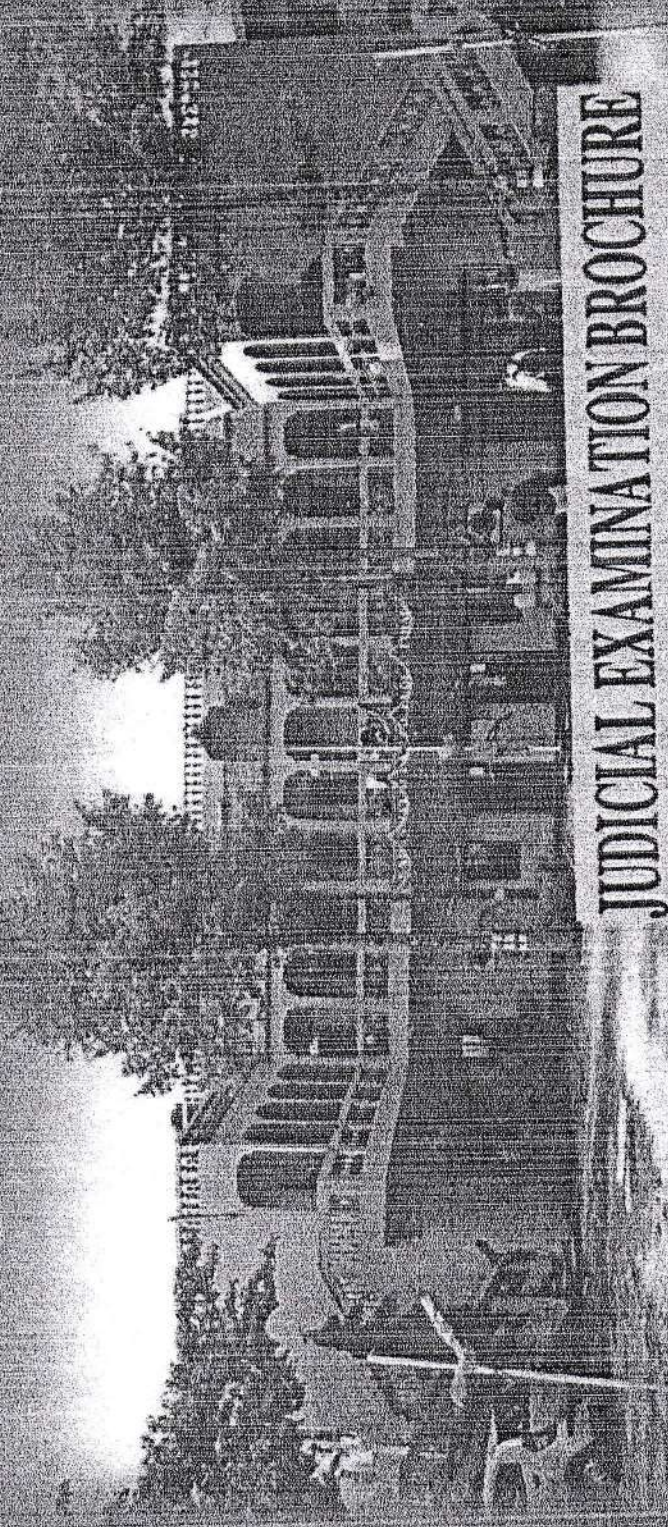

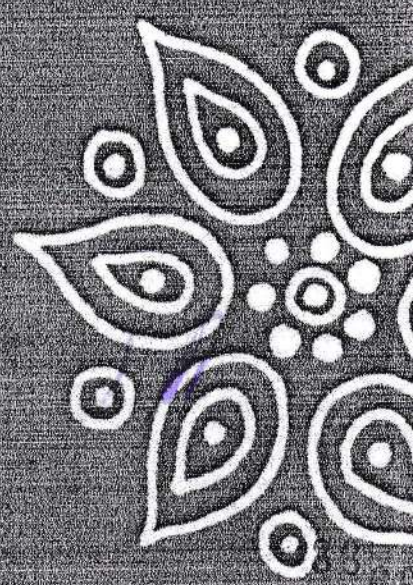

Karnataka Judicial Service Exam (Civil Judge)

Overview & Syllabus

The Karnataka Judicial Service Examination is conducted every year by the Karnataka High Court for recruitment to the posts in the Civil Judge cadre of the Karnataka Judicial Service (KJS).

The notification is normally published on the Karnataka High Court's official website at: <https://karnatakajudiciary.kar.nic.in> and / or the website of the Karnataka Public Service Commission (If the exam is conducted by the KPSC) at Karnataka Public Service Commission. These Civil Judge posts in the Karnataka Judicial Service (KJS) were previously referred to as Civil Judge Junior Division.

Contents:

Eligibility and Age Limit – Karnataka Judicial Services Civil Judge

1. Candidate must be holder of a degree in Law granted by a University established by Law in India and must have been enrolled as an Advocate. (I.e. Completed LLB from a BCI recognized college / University and enrolled as an advocate as per the Advocates Act and BCI rules.)
2. General and non-reserved category candidates must not have completed 35 years of age as on the last date fixed for receipt of applications (as per the official notification of the year). Candidates belonging to Scheduled Caste or Scheduled Tribe must not have completed 38 years of age as on the last date fixed for receipt of applications (as per the official notification of the year).
3. There will be a relaxation of three years in the upper age limit for Ex service men candidates.
4. Refer to the official advertisement for details of the age limits and other details for 'In Service' candidates.

Overall Scheme of the Karnataka Judicial Service Civil Judge Exam:

The Competitive Examination for recruitment of Civil Judges (Karnataka Judicial Services) shall consist of 3 stages i.e.,

- a. Preliminary Examination – Objective type with multiple choice questions.
- b. Main Written Examination – Descriptive / Narrative / Essay type.
- c. Viva-Voce – Personal Interview

* The marks secured in the Preliminary Examination are considered only for Eligibility for the Main Written Examination. i.e. Candidates will be shortlisted for the main examination basis their ranking in the preliminary exam. The preliminary marks are not considered for the final rankings.

A. Karnataka Judicial Service Examination–Preliminary Syllabus

B. Karnataka Judicial Service Civil Judge Exam – Main Papers Syllabus

1. Translation Paper (Maximum Marks 100)

There will be one translation paper and the candidates will be required to translate passages in English into Kannada and Kannada into English. The Passages will be from

1. Depositions,
2. Judgments,
3. Documents.

2. Law Paper I (Maximum Marks 100)

1. The Code of Civil Procedure, 1908;
2. The Code of Criminal Procedure, 1973;
3. The Indian Evidence Act, 1872;
4. Principles of Pleading,
5. The Constitution of India.

3. Law Paper II (Maximum Marks 100)

Framing of Issues and writing of Judgments in Civil Cases.

4. Law Paper III (Maximum Marks 100)

Framing of Charges and writing of Judgments in Criminal cases.

C. Karnataka Judicial Service Examination – Viva-voce (Maximum Marks 100)

The candidates General Knowledge, grasp of principles of law and suitability for appointment as Civil Judge shall be tested.

D. Karnataka Judicial Service Examination – Computer Test (Maximum Marks 25)

The test of knowledge of computers shall carry maximum 25 marks and such marks secured by the candidate shall be considered for ascertaining the suitability and computer knowledge of the candidates and shall not be aggregated to the total marks obtained in the main written examination and Viva-Voce.

Note: Regarding (b) and (c), such of those candidates who desire to answer in Kannada may do so.

E. Minimum Marks to qualify for the Karnataka Judicial Services.

- I. Minimum marks for pass in the Preliminary Examination shall be 50 for candidates belonging to Scheduled Castes and Scheduled Tribes and 60 for others.
- II. Minimum marks for pass in each paper of the Main Written Examination shall be 40 for candidates belonging to Scheduled Castes and Scheduled Tribes and 50 for others.
- III. Minimum marks for pass in the Viva-Voce shall be 40 for candidates belonging to Scheduled Castes and Scheduled Tribes and 50 for others.

Provided that no candidate who has secured less than the minimum marks specified above:

1. In any paper of the Main Written Examination shall be eligible for Viva-Voce.
2. In any paper of the Main Written Examination or in viva-voce shall be eligible for appointment as Civil Judge. (f) In order to be considered under General Category, a candidate belonging to a Scheduled Caste or Scheduled Tribe has to secure the minimum marks prescribed for General Category in the Preliminary Examination, Main Written Examination and Viva-Voce.

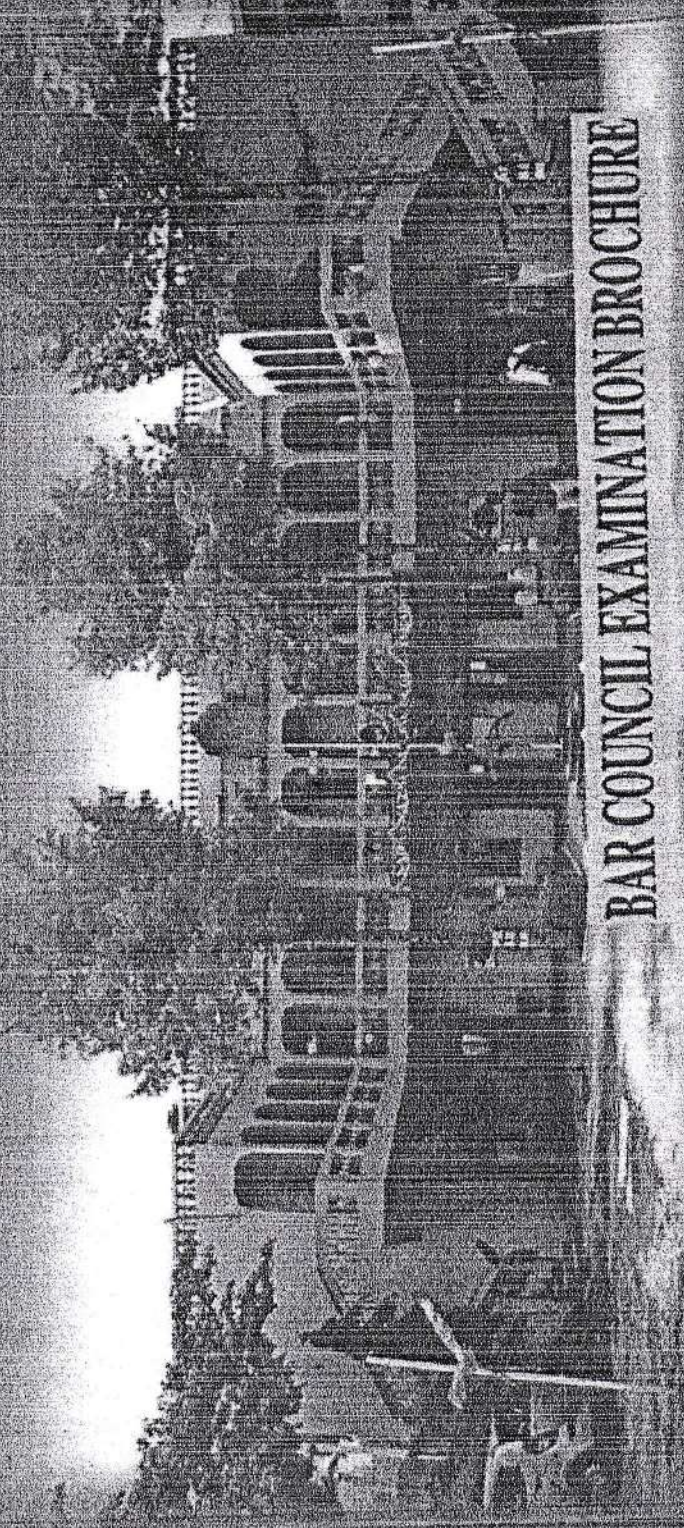

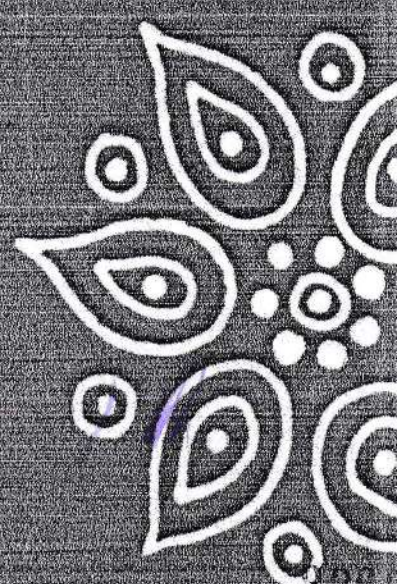

ALL INDIA BAR EXAMINATION PROCEDURE

The All India Bar Examination (AIBE) was conducted for the first time on December 5, 2010, by the Bar Council of India. The exam aims to assess a lawyer's capabilities to practice law in India and intends to set a minimum standard for admission to the practice of law in India; it addresses a candidate's analytical abilities and basic knowledge of law.

The Bar Council of India (BCI) awards a "Certificate of Practice" to advocates who clear the AIBE. The certificate will be mailed to the advocate's address within 30 days of the declaration of the AIBE results.

All students graduating from academic year 2009-10 onwards have had to clear the exam to practice law in India. There is no limit to the number of times you can appear for the All India Bar Examination.

In the event of not clearing the All India Bar Examination in the first attempt, you can appear for it the next time and clear it to obtain your Certificate of Practice. You can apply to take the All India Bar Examination only after you have enrolled as an advocate with a State Bar Council. There is no limit on the number of times an advocate can appear for the AIBE.

There are no benefits available for advocates in the SC/ST category who are attempting the All India Bar Examination

AIBE Eligibility Criteria

In order to be eligible to appear for AIBE, candidates need to fulfill the following criteria:

- You must clear LL.B.
- You must be enrolled with any State Bar Council

AIBE Application Fees

The application fee for both first-time (fresh) and a repeat candidate is Rs. 2500 (plus Rs.60 SBI bank surcharge.)

AIBE Application Procedure

1. You can only register online for the allindiabarexamination.com/registration.aspx
2. After registering, candidates have to log in to their respective accounts.
3. Get a print out of the "bank challan" after logging in to your account.
4. Fill in the bank challan and submit it along with the application fee at the nearest branch of State Bank of India (SBI). It takes approximately 24 hours for a candidate's registration to be effective, so make payment only a day after registering.
5. Wait to get the payment acknowledgement (it takes approximately 12-24 hours). Then proceed to see your registration details by logging into your registration account.
6. Now click on the "Upload Challan and Details" button and upload your copy of challan (jpg/ jpeg image) that has the bank seal and signature and also update your challan details into your account (journal number, branch code, date of challan)
7. Now click on the "Application Form" button and take a printout of the filled out form (for your own reference.)

All India Bar Examination Syllabus - In details

The topics that are given in the syllabus of AIBE are explained below in brief.

Administrative Law - Administration of the country is carried out by the executive body and administrative officers. The power that they exercise on the public for an effective administration broadly constitutes the administrative law. Candidates will be expected to know about the different administrative bodies and such laws.

Alternative Dispute Redressal including Arbitration Act - When the parties involved in a dispute present their case to a neutral party. The neutral party is called the arbitrator. There are several judicial and quasi-judicial bodies that function on a given framework of law and constitution. Candidates should have the awareness related to dispute redressal bodies and laws.

Code of Civil Procedure - The two-part code contains 158 sections in the first part and the First schedule in the second part. The code of Civil Procedure governs the civil proceedings in India.

Company Law - This section includes topics which define the rights and conduct of organisations or businesses and the people associated with it.

Constitutional Law - Covers the laws in the Indian Constitution.

Criminal Procedure Code - Defines the procedure to be carried out in a criminal case and basically runs the whole system.

Cyber Law - The subject is gaining popularity as the world moves towards digitalisation. Deals with crimes related to the internet, cyberspace, etc.

Environmental Law - Covers law to regulate pollution, use of natural resources, protection of flora and fauna, international conventions, various agreements, laws related to environmental clearance, NGT etc.

Evidence Act - Also called the Indian Evidence Act, 1872.

Family Law - Deals with disputes between family members or relations.

Indian Penal Code (IPC) - It is the official criminal code of India and has been amended several times. This section also covers the supplementary criminal provisions of IPC.

Intellectual Property Laws - This law protects the ownership of property. The property here includes both tangible or intangible assets, thus can be anything from art to real estate. laws related to patent, GI indication, etc are also covered in the section.

Labour and Industrial Laws - Defines the relationship or code of conduct between the employee and employer. Candidates are expected to be aware of the labour codes, recent labour reforms approved by the government of India, Norms and laws related to International Labour Organisation etc.

Land Acquisition Act - Governs the acquisition of private land for commercial or public utility. It also defines the compensation. One should be aware of the different legalities of land acquisition, supreme court guidelines and other laws passed by the parliament.

Law related to Taxation - Governed by the Income Tax Act, 1961. Further, it may also cover the tax reforms initiated by the Govt of India in recent times including GST.

Public Interest Litigation - Issues of public interest or mass interest. General laws related to the PIL etc.




