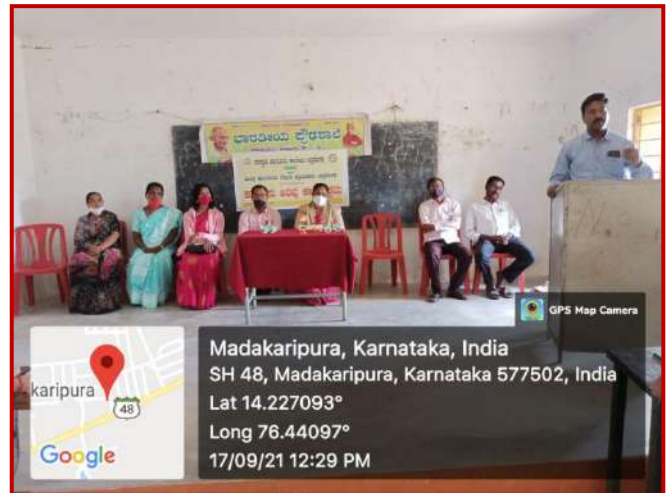

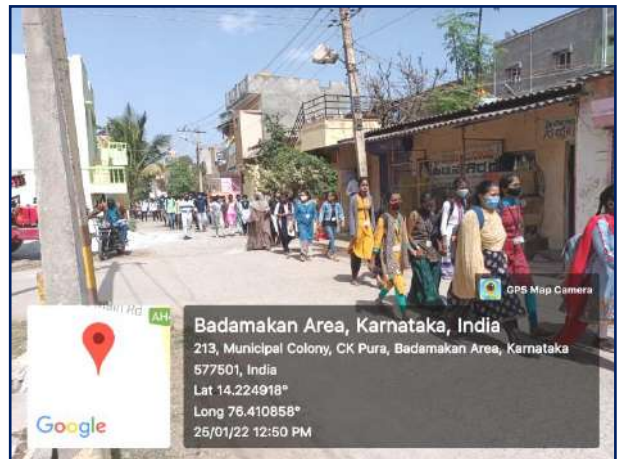

Report of World Malaria Day

Date: 25.04.2022

The Institutions in association with Zilla Panchayath, District Administration, Department of District Health & Family Welfare, N.S.S. Chitradurga had observed World Malaria Day on 25th April, to bring global attention to the efforts being made to bring an end to Malaria and encourage action to reduced suffering and death from the disease.

Smt. Pushpa, ASHA worker chanted the invocation, Sri. Abu Saleem, Senior Health Education Officer, Chitradurga proposed welcome speech on the occasion.

Dr. Kashi, District Malaria Officer, Chitradurga said that Malaria is an acute febrile disease caused by the Parasite Plasmodium, which is transmitted by the bite of an infected female Anopheles Mosquito. Symptoms, including fever headache and chills usually appear 10-15 days after a bite and may be mild and difficult to recognise as Malaria. Left untreated, malaria can progress to several illness and death. He also said that we are so fortunate that in Karnataka cases are very less and hopefully by this yearend by taking simple precautions at home we can make the Malaria cases nil.

Dr. Nandini Kadi, Entomologist emphasised that leveraging technology and innovation will help in developing tailor-made solution to advance India's malaria's elimination plan and contribute to improved health, quality of life and alleviation of poverty. She added that ground level frontline health care workers including the ASHAs and Department of District Health & Family Welfare along with partner organisations need to work in tandem for creating mass awareness about diagnosis, timely and effective treatment and vector control measures.

On this occasion the Chief Guest of the program Sri. M.B. Hanumanthappa, Supervisor of Communicable Diseases, Chitradurga said that World Malaria Day 2022 is marked under the theme “Harness innovation to reduce the Malaria disease burden and save lives”. He also said that not only diagnosis and treatment, swachhata in our personal in community surrounding and social awareness regarding malaria control and prevention are equally important in our collective fight against malaria and for meeting our goal of elimination of malaria from our country by 2025.

Sri. N.S. Manjunath, Taluk Health Education Officer, Chitradurga while delivering his welcome address said that India has made remarkable progress in reducing the malaria incidence and deaths. 124 Districts in our Country have reported “zero malaria cases”. 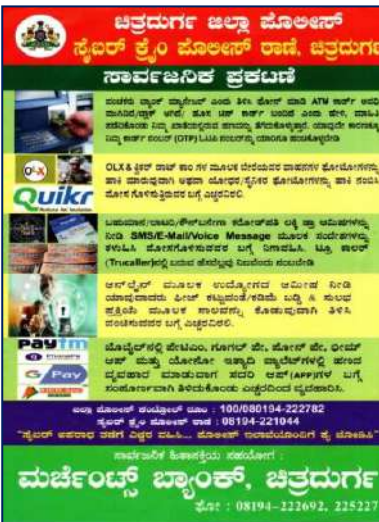

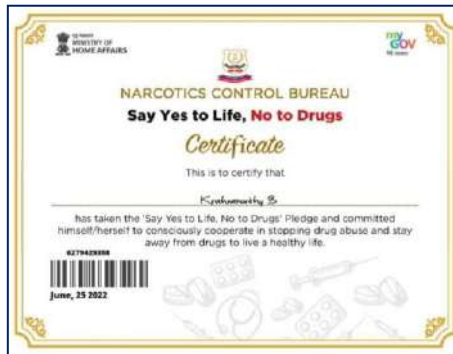

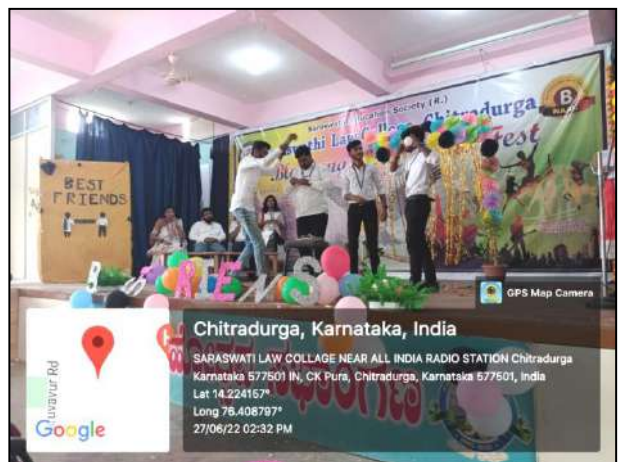

Report on a Special Lecture on ‘Making of Constitution and its Basic Features’

Date: 25.07.2022

An expert special lecture on “**Making of Constitution and its Basic Features**” was organised on 25th July 2022 at Saraswathi Law College Auditorium, Chitradurga.

The program was compared by Sri. P.C. Murugeshappa, Physical Education Director, Saraswathi Law College, Chitradurga. The program began with the beautiful tone of “Vande Matharam”, the National Song sung by students which was followed by Oath taking ceremony which was further followed by the heartily welcome speech delivered by Dr. N.D.Gowda, Assistant Professor, Saraswathi Law College, Chitradurga. Further the program was inaugurated through watering plants by the Chief Guest and other dignitaries on the Dias.

The keynote address was given by Sri Ananth Naik. N, Advocate, High Court of Karnataka, Bengaluru. He gave the advertisement of the book “Samvidhana Odhu” and said the importance of the book which is needed to be read, discussed and commented.

Sri. H. Hanumanthappa, Hon’ble President, Sarsawathi Education Society, Chitradurga gave the brief of the Constitution and said that the aim of the special lecture is to equip students with the basic features of the constitution and how it had enshrined.

Hon’ble Sri H.N. Nagamohan Das, Retired High Court Judge, High Court of Karnataka, Bengaluru. He began the lecture by saying that the modal of Constitution is not meant for only lawyers and law students. It had developed for the whole young community and invited to read, discuss and debate. From past 73 years no one have read and understood it.

The speaker stressed upon clear directions that the students must have strong knowledge about the basic structure of the constitution. For that first of all one should understand India. Nation is not just land, it is made out of people.

He also informed the students about History of Constitution that is how the concept of Constitution emerged in Ancient Indian History, Medieval Indian History and at present. Further, he also elucidated how our freedom fighter had taken initiation to draft the constitution.

The constitution of India is the supreme law of India it imparts Constitutional Supremacy, (not parliament supremacy, since it was created by a constituent assembly rather than parliament) and was adopted by its people with a declaration in its preamble.

Parliament cannot override the Constitution. It was adopted by the constituent assembly of India on 26th November 1949 and became effective on 26th January 1950.

The constitution declares India a sovereign, Socialist, Secular and Democratic, Republic, assures its citizens justice, Equality and Liberty and endeavours to promote Fraternity.

After delivering his lecture he encouraged students to clear their doubts and clarified many doubts of the budding advocates. The students were highly benefitted by this session. It was very informative and interactive session where students came to know about making of Constitution and its basic features.

Smt. D.K. Sheela, Senior Advocate, Secretary, Saraswathi Education Society, Chitradurga, proposed vote of thanks with aspirants of looking forward to many such conclaves with experts who can enhance the knowledge of our budding lawyers.

The day adjourned with a great sense of awareness and knowledge. There were about 230 participants, comprising students, faculty and media people.

Date: 13.08.2022

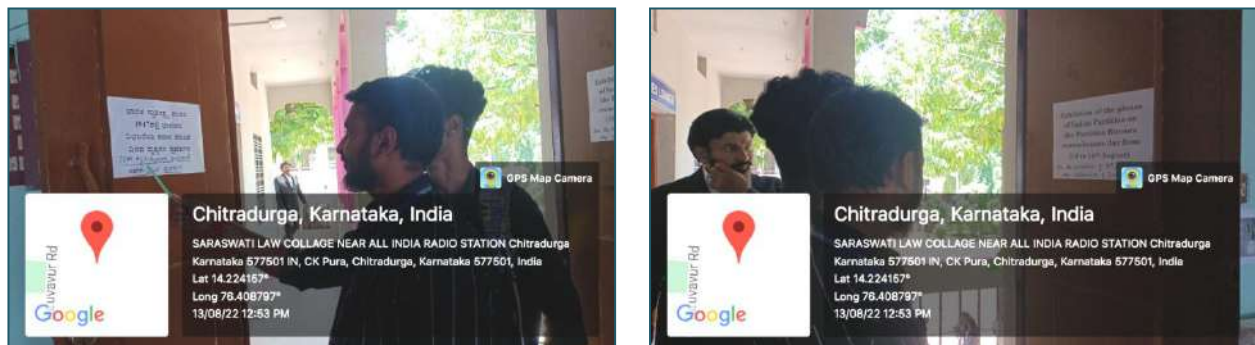
The Institution had organised the Exhibition on the history of India's Partition under the direction of University Grant Commission on the occasion of **Partition Horrors Remembrance Day**.

The division set of communal violence and displaced millions, changing the face and geopolitics of South Asia. Polarised by Religion, Friends and Neighbours turned on each other. Hundreds of thousands were killed and millions displaced. The atrocities were horrific- pregnant women and infants were not spared.

That was the unexpected results of Britain's haphazard plan to leave the sub continent in 1947 after nearly three centuries and split in to Hindu- Majority India and Muslim- Majority Pakistan, itself carved in to two regions more than thousand miles apart. The partition, as the division came to be known, triggered one of the biggest migrations in history.

Most Indians, Pakistanis and Bangladeshis today were born a generation after partition. But its repercussions endeavour. India and Pakistan have fought three wars skirmishing often over claims to Kashmir, India's only Muslim-Majority State. The liberal ideas espoused by the founders of both countries now appear to be forgotten to history.

What follows is a photographic record of the period around the partition of British India.

Sudhadevi addressed the gathering and briefed that how demand for Pakistan lead by Mohammed Ali Jinna of the All India Muslim League contributed to one of the biggest Hindu-Muslim riots in India in August 1946, when at least 2000 people were killed in five days in Calcutta, then the capital of the province of Bengal. Over the next few months more communal fighting followed. With this inspiring speech students sung the National Anthem with more patriotism.
