



Hanumantharaya, Senior Advocate, Chitradurga was the guest of the occasion who covered few key concepts of Criminal Pleadings like (1) Criminal Pleadings are required to confer jurisdiction on the court, provide notice to the defendant and ensure against double jeopardy. (2) The pleadings in District Court are usually summons, warrant, magistrates order or statement of charges. (3) The pleadings used in Superior Court are usually an indictment or information, but in some circumstances may also include a grand jury presentment, bill of particulars, or misdemeanor pleadings on appeal.

He also covered essential contents of Criminal Pleading. He then focused on Bail under section 436 of the Criminal Procedure Code, which says Bail is the Right of Person, who has been accused for commission of offence, which is bailable in nature. He covered the concept 'Bail', 'Bail Bond', Types of Bail, Process of Bail, Conditions of Bail and so on. The programme was concluded by vote of thanks which was delivered by L. Srishyla, Assistant Professor.



Sadashivappa, Senior Advocate, District Court, Chitradurga. The programme began with the welcome speech delivered by Kumari Sai Nikitha of Final year 3 years LL. B. course student. There after the stage was occupied by the resource person and started his commendable lecture on Civil Procedure Code. He said, Procedural law or adjective law prescribes the procedure and machinery for the enforcement of those rights and liabilities. To say, in other words, the procedural law is concerned with enforcement of those rights and liabilities determined in accordance with the rules of the substantive law. The Law relating to the practices and procedure to be followed in the Civil Courts is regulated by the Code of Civil Procedure, 1908.

The main object of this civil procedure code is to consolidate and amend the laws relating to the procedure and practices followed in the Civil Courts in India. As this Code is a general procedural law, it does not contradict with the local or special law in force. In the event of any conflict between the civil procedure code and the special law, the special law will prevail over the civil procedure code. In case the local or general law is silent on any matter, then the provisions of the civil procedure code will prevail.

There are many Changes brought by Amendments of 1999 and 2002 so as to cope-up with the current requirements. The main object of the amendments is to ensure fair and natural justice and providing a speedy remedy by eliminating untoward delay in disposal of the cases. After the inspirational lecture on the said topic, the time was provided for question from the students, which was addressed by the resource person in a most convincing way. The programme was dissolved by proposing vote of thanks delivered by Smt. Chethana. B.H of Final year 3 years LL.B. Course student. Around 95 students were present on the occasion and got benefitted.

He said that Sexual abuse is quite rampant in India and both girls and boys are vulnerable to it. There are still many non reported cases which encourage the offender to continue such abuse.

Smt. Harsha. S. M., Assistant Professor, Saraswathi Law College and the co-ordinator of the programme addressed the gathering and said 'Early detection of Child Sexual Abuse is the need of the hour due to the factors like:

- It will help the situation to get worse in terms of halting the progress from less severe form to more severe form;
- It will help in overcoming the trauma caused by the abuse;
- It will prevent sexually transmitted diseases and unwanted pregnancies; early reporting will help in speedy processing and early justice;
- It will help in separating the perpetrator from the victim and reduce the risk of repetition of the offence;
- Lowers the severity of long-term psychological impact on the victim.

The programme concluded with the presedential remark delivered by Headmistress Smt. Divya, Kote High School, Chitradurga, She said Keeping in view the growing imbalance in the man-woman ratio, we have to emphasize focusing on celebrating and welcoming girl child. To get rid of vicious social customs of dowry system responsible for killing of girl child, the status of women shall have to be enhanced.

Special Lecture on Procedure of Registration of Property

Date: 16.02.2024

The Institution organized a Special Lecture on Registration of Property on 16th February 2024. Sri Rajanikanth. P. Office of the Sub-Registrar, Stamps and Registration Department, Chitradurga was the Resource person on the occasion. The programme began with the Welcome speech delivered by Smt. Renuka H. of 3 years, Final year LL.B. Student.

Sri Rajanikanth. P, the resource person gave a brief introduction on the importance of property registration. He said Property registration is an essential process that enables the government to maintain a proper public record. It helps the City Survey and Land Records Department to decide the value of the tax on property and levy property tax from the right owner.

The property registration must be formalized at the sub-registrar's office following payment of certain dues, such as stamp duty, for it to be considered complete when a property is transferred from one person to another. The procedure is referred to as "property registration."

The Indian Registration Act of 1908 is the primary legal authority on the subject of document/property registration legislation. This legislation requires the registration of a number of different papers in order to guarantee the authenticity of titles, safeguard against fraud, and preserve evidence.

Then the resource person covered the Steps to follow for property registration. Online property registration tips were also given to the students. He said that in the majority of Indian states, the buyer is able to finish a significant portion of the procedure of property registration online. You may be able to use the internet services to complete some of the steps of the property registration procedure, but this will depend on the state in which you reside.

However, in order to finalize the transaction, you will need to present yourself in person at the office of the sub-registrar, together with the person you are purchasing the property from and two witnesses. You will need to come back to our office after the paperwork has been registered so that you may obtain the registered copies of your property documents.



Report of State Level Workshop on New Criminal Major Acts: Changes and Impact on Criminal Justice

Date:07.06.2024

The institution gave an opportunity to attend State Level Workshop for the criminal laws subject teachers and two students to upgrade the knowledge with respect to the new criminal major acts, for this they have visited shivamogga to National college of Law and Centre for Post Graduate Studies In Law, Shivamogga in Association with Alumni Association of CBR National College of Law Shivamogga had organised state level workshop on "New Criminal Major Acts: Changes and Impact on Criminal Justice". For creating awarness on the new Three criminal laws, namely The Bharatiya Nyaya Sanhita, 2023(BNS); The Bharatiya Nagarik Suraksha Sanhita, 2023(BNSS) and The Bharatiya Sakshya Adhiniyam,2023(BSA) repealing The Penal Code,1860 The code of criminal procedure,1973 and The Evidence act, 1872.

In the Inaugural address delivered by Manjunath Nayak, Principal Dist And Session Judge, Shivamogga., he said that the new three criminal laws are the watershed moment of our society, because no law affects the day to day comdut of our society like criminal law. He also said judge made laws are been changed into parliament made law.

P. Narayan Director of National College of Law talked about the changing landscape of India and said the essentiality of the awareness regarding new criminal laws. Dr.Anala, Principal CBR National College of Law Shivamogga set the tone for the conference and introduced the theme of the conference, she said that this is a journey of enlightment and exploration into the heart of one of the India's most crucial endeavours, the transformation of the criminal justice system.

In the first session sri H.D Ananada Kumar Retd., Public Prosecutor Advocate Mysuru said that BNS has brought in significant chages in substantive criminal law, while retaining a substantial part of penal code ,1860. The BNSS, imtroduces on the otherhand,sweeping changes in the procedure designed to galvanise India's justice sytem through the imposition of strict timelines for various stages and aspects of investigation, enquies, trail, judgements and appeals as also by the imtroduction of kiberal use of the electronic medium to emhance its efficacy. It is victim friendly and gives opportunities to accuse of fair representation. He discussed the chapterisation of the BNS. He highlighted that the problem of complicated and scattered chapters under the IPC has been resolved and discussed how

the chapter five of the BNS consolidates the offeces relating to women and children at one place, which were previoudly scattered under four separate chapters of the IPC. He also said that arrangement of offences is in the manner, which is easily understood to layman. All the major reforms, significant judgements in the past 75 years have been included in the BNS.

The Chairman of first session Pramath Adiga spoke on the occasion by higlighting that the change is not about mere changing the scheme of the Act but to include the prespective of a common citizen.

In the second session Sri H.D Ananada Kumar Retd., Public Prosecutor Advocate Mysuru while discussing the scheme of punishment, he said that earlier the shift was from Deterrent to Retributive ,but now the change is from Retributive to Reformative. Why discussing the implementation of this newly introduce punishment, he highlighted the six offences, for which the community service has been prescribed. Quoting fro, mahabharatha- "I know what dharama is, but I cannot walk on that path", he said that the socio economic condition and psychology of a person influences their criminal behaviour and he concluded by saying that time is the test for these increased punishments, as to how effectively they will reduce the crime, deterrence, alone, is not sufficient.

The chairperson of theprogram in the second session Sri Krishna Rao narrated the strikeing balance between over criminalisation and decriminalisation, stated that criminality is like gunpowder lying harmless in the gun, unless it is ignited by some external acts. He discussed some important deletions, susch as section 377, 124A, 309,etc. In respect to over-criminalisation, he said that the hit and run matters, has been recognised and it is a laudable move that the same has been put under section 106of the BNS and the punishment is enhance to 10 years.

Few audience expressed their opinion about the workshop by conveying the effectiveness and knowledgeable information delivered by the speakers. The programme was dissolved with the vote of thanks delivered by Mrs. Anupama assistant professor, CBR National College of Law Shivamogga.

Date: 12.06.2024



The Institution had organized a Special Lecture on Monday 8th July 2024 at 12:00 pm in Golden Jubilee Auditorium, Saraswathi Law College, Chitradurga. The program was compared by Sri P. C. Murugeshappa, Physical Education Director, Saraswathi Law College, Chitradurga. It began with the Invocation song sung in a patriotic mood by student Bhoomika G R and team. It was followed by Pledge taking ceremony carried by Sri P. C. Murugeshappa, Physical Education Director.

Prof. Dr. M. S. Sudhadevi, Principal, Saraswathi Law College, Chitradurga highlighted the bird view about the college, significance of the ceremony to students and welcomed the dignitaries and gathering followed by lighting of the inaugural lamp lit by the Hon'ble Justice Shri. N. Santosh Hegde, Former Judge of Supreme Court of India, Former Solicitor General of India and Former Lokayuktha, Karnataka and other dignitaries on the dais.

Smt. Harsha. S.M., Assistant Professor, Saraswathi Law College, Chitradurga gave an introduction of Hon'ble Justice Shri. N. Santosh Hegde, Former Judge of Supreme Court of India, Former Solicitor General of India and Former Lokayuktha, Karnataka, which was followed by Inaugural speech.

Hon'ble Justice Shri. N. Santosh Hegde, addressed the gathering by informing the students when and where the prefix are to be used for the name and cited the Supreme Court case law which holds good regarding the matter. He also cited examples of specific cases where he witnessed corruption in administration from various forms of public services. "We cannot blame individuals because this fault lies with society. Earlier, there was social centralization of criminals; and role of families, parents and moral science education were significant in shaping our minds. But today, the social fabric itself has changed. Unfortunately, today's society respects only money and power, while honesty often takes a backseat."

"Only education cannot give value to the society. Our objectives and attitudes should also be good. When the students become employees in future, they should fight against the corruption. Corruption is rampant in all the four pillars of the Constitution like Legislature, Executive, Judiciary and Media. It's unfortunate that there are no serious discussions and debates in Parliament and Assembly. Our elected representatives have been spending time in meaningless debates or commotions. As a result, public money is being wasted", he said.

He reminded some of the major scams to have plagued our country for the past few decades and as to the huge amounts of public money that were siphoned off from administration. "Such people are not afraid of law. No one wants to bring about change and blame game becomes the order of the day. Where is democracy and how can true development happen in this kind of a situation? What is the way out of this to bring about peace and solidarity of the nation?" he left the question open to the audience.


He also spoke about the mining report that he authored which was released in 2011, saying his recommendations were not implemented by successive governments. "The only way out of this rut of ever-increasing greed is inculcating a value of contentment. Be content with what you legitimately have. I know a lot of dedication and determination is required for this. But once it is accomplished, any amount of temptation can be countered."

His talk was followed by a Q&A session with the audience, during which he suggested that to fight when the system itself is choked, people within and outside the system should be willing to change. "The time has come to reduce the number of appeal forums and thereby speculative litigation, which will result in quicker decisions by the Judiciary."

To another query about making policies more people-centric, he suggested, "Confine the Supreme Court for constitutional matters only. For policy matters a different forum should be created. Around 25 questions were posed by the students and all those were answered in a most zealous and patience manner by Hon'ble Justice Shri. N. Santosh Hegde. Further more questions from students were waiting in a queue, but due to time constraints it was necessary to end the program.

Felicitation was made to Hon'ble Justice Shri. N. Santosh Hegde by Sri Fathyarajan, Senior Advocate, Vice President, Saraswathi Education Society, Chitradurga, and Smt. D. K. Sheela, Senior Advocate, Secretary, Saraswathi Education Society, Chitradurga, with Shawl, Garland, Fruit box, Memento. Student Law Forum members also felicitated Hon'ble Justice Shri. N. Santosh Hegde with Shawl and memento.

Dr. K. S. Kariyanna, Assistant Professor, Saraswathi Law College, Chitradurga proposed Vote of thanks. The program was winded up by singing National Anthem in chorus. More than 300 students were benefitted by this program.

Report on NSS Camp at Sajjanakere Village, Chitradurga Taluk Date: 12.07.2024 to 18.07.2024







Report on National Lok Adalat Court Visit

Date: 13.07.2024

Lok Adalat is one of the Alternate Dispute Redressal (ADR) mechanism and the members of Legal Aid Society, and Saraswathi Law College Students volunteered for the National Lok Adalat, 2024 which took place on 13th July 2024 in Chitradurga District Court Complex. The students had the opportunity to witness and learn in person as to how a Lok Adalat works.

The Lok Adalat's dedicated to property-related disputes. These cases encompassed issues like illegal occupation of someone else's property, causing harm to individuals or property, and instances where multiple individuals were involved in criminal acts under Section 34 of the IPC. The Lok Adalat, through its mediation and conciliation processes, succeeded in bringing parties together and reaching mutually acceptable solutions. This not only expedited the resolution of these matters but also contributed to the restoration of peace and harmony in the community.

Following the motor vehicle-related cases and property related disputes, the Lok Adalat also took up criminal cases which were compoundable in nature, involving sections 447, 323, 427, and 34 of the Indian Penal Code (IPC). These cases were diverse in nature and involved offenses such as trespassing, causing hurt, mischief, and damage to property. What stood out was the commitment of the Lok Adalat to encourage amicable settlements and reconciliation between the parties involved. Mediation and dialogue played a significant role in resolving these disputes, ultimately reducing the burden on the traditional court system.

The visit to the Lok Adalat provided valuable insights into the functioning of this alternative dispute resolution forum. It was evident that the Lok Adalat serves as a crucial pillar of our legal system, promoting speedy justice and reducing the backlog of cases in traditional courts. The emphasis on reconciliation and mediation in resolving disputes, whether related to the Motor Vehicles Act or property issues, was commendable. The Lok Adalat's ability to settle matters with fines, compensation, or amicable agreements not only benefits the litigants but also contributes to the overall efficiency and effectiveness of our legal system. We appreciate the dedication and efforts of the legal professionals and mediators at the Lok Adalat for their role in upholding the principles of justice and harmony. Students visit to the Lok Adalat was an enlightening experience, showcasing the significance of alternative dispute resolution mechanisms in our quest for a just and equitable society.

PRELIMINARY ROUNDS:



Report on creating Awareness about POCSO Act and The Prohibition of Child Marriage Act among school Children

Date: 28.08.2024

The Institution Organized an awareness programme on POCSO Act and Child Marriage in Agasanakallu Government School, Chitradurga on 28th August 2024. The Protection of Children from Sexual Offences Act, 2012 for short POSCO Act and The Prohibition of Child Marriage Act 2006 is an important concept to be sensitized to the children, because Schools are environments where children spend a significant amount of their time. Awareness will ensure that children are protected from sexual offences at school. Educating students about their rights and how to recognize and report abuse can empower them to protect themselves and others

The programme was compared by Smt. Manjula. M. R, Social Teacher Agasanakallu High School, Chitradurga. It began with a warm welcome speech delivered by Sri Karibasappa. K, Hindi Teacher, Agasanakallu High School, Chitradurga.

The resource person of the programme was Prof. Dr. M. S. Sudhadevi, Principal, Saraswathi Law College, Chitradurga. She raised awareness on good touch and bad touch and highlighted the POSCO Act. She further informed that even the death penalty can be awarded for committing sexual crimes on children. Considering the gravity of sexual crimes on children, she exhorted the children to report such cases to the Parents or Teachers or the person whom they trust so as to bring a complaint to the police station to award stringent punishment to the perpetrators as per law.

Smt. Harsha. S. M., Assistant Professor, Saraswathi Law College, Chitradurga addressed the gathering and said Child Marriage is a toxic that ruins young lives. Many a time, early marriages are done to bring child brides into forced household chores. This has a serious burden on young girls which leads to health, safety, bodily integrity and self determination issues. She also quoted that many are not even aware of the correct legal age of marriage for girls and boys. Thus, awareness within the community is very much required. She made the program more interesting by explaining

how children and parents will be trapped to child marriage with a short story. She explained the topic by putting different examples. The children were also informed about child Help line-1098 and 112 and advised to report any case of child abuse or child marriage or any trouble.

Smt. Uma Maheshwari, Head Mistress, Agasanakallu Middle School, Chitradurga addressed the gathering and said that the child victim of sexual offence could be a boy or a girl both can seek a protection under POCSO Act and the offender too can be male or a female both can be punished alike. Regarding child marriage the law is armed with enabling provisions to prohibit child marriage, protect and provide relief to victim and enhance punishment for those who abet, promote or solemnize such marriage.

Sri Thippeswamy H. M. HeadMaster, Agasanakallu High School, Chitradurga delivered the presidential address and said that this awareness programme aimed to educate students about the laws and empower the children to identify signs of abuse or coercion and raise their voice against wrong activities made to them and be in a protective zone. He also highlighted that the parents and guardians should be aware of the provisions of the child welfare Acts in place for its effective implementation.
