#### 2) Objectives of the Fest:

Students were instructed with certain rules and regulations such as:

- Students are hereby informed to follow dress code strictly.
- "Best Organizer" award will be given to the class to organize the events systematically in time.
- The organizers are supposed to organize the events as per the time table provided.
- The class who need to organize the event should provide the rules of the events beforehand.
- The organizers as well as participants are requiring to get arranged for their costumes and other property by themselves.

- Multiple entries by one person are not allowed.
- Any act of indiscipline by participants will be disqualified.

 Judging will be based on overall appearance, clarity in rangoli art, colour combination and creativity.

**Written Qualifying Quiz** was organized by Teaching Staff, for which Dr. N. D. Gowda, Assistant Professor was the co-coordinator. We received a magnificent number of participation in this event i.e around 90 students took part in this event. - There is no restriction on language.

## Singing Competition:

"Music is a world within itself, with a language we all understand" to unite hearts through Music Three years 1<sup>st</sup> sem., students organized this Singing Competition on 10<sup>th</sup> February 2024.

Rules for Singing Competition:

- The song chosen to perform must not contain ny vulgarity or it should be in a manner that the fillings of any religion or community should not get hurt.
- The choice of the costume will be considered.
- The judges would pay attention to the body language and the expressions of the performer, pitch, tone etc.
- The final decision will rest with judges only.
- The time limit is fixed between 2-3 minutes.

# Third Day Events of Koustubha Law Fest Date: 21.02.2024

On the third day the maximum students were dressed up with yellow colour dress code and began the program with full of energy and dedication. The day commenced with Dumb Charades. Five years 5<sup>th</sup> Sem B.A.LL.B students organized this event. Around 26 participants participated in an event. Dumb charades is a fun activity where participants have to act out a word or phrase without speaking, and the other participants have to guess what it is. To make the students more clear about the action and in order to bring out their hidden talents and showcase their acting skills this event was arranged.

#### Rules for **Dumb Charades**:

- Two members in a group.
- The performance has to be silent with no words as the word 'dumb' goes.
- The player has to use facial expression, gestures and body language.
- Clues like lip-reading, humming songs, pointing and spelling are banned.
- Language, number of words must be said at first.
- There is a particular time limit for teams to guess i.e. 60 seconds.
- There will be four rounds in this event like Proverb round, Word guess round, Legal term round, Films and actor personalities round.

**Cooking without fire, Elocution and Mimicry competitions** were commenced in different class rooms simultaneously. Cooking without fire competition was organized by Five years 1<sup>st</sup> sem., students in a most systematic way. In all 27 students participated wholeheartedly in the event. Their efforts were evaluated on the basis of five parameters: i) Dish name, ii) Taste, iii) Presentation, iv) Calorie content and v) Hygiene. Participants infused lots of creativity and served delicious eatables to enhance the taste buds. Here the participant had to prepare an eatable without using the fire. So the participants served plates of Bhel puri, Chaat, andwiches, shakes, Mojito, Chocolate lollypop Dry fruits laddu and many more.

Rules of Cooking without fire:

- One team may contain a maximum of 2 members.
- Pre-registration is mandatory.
- Total preparation time 40-45 minutes.

- All the items required for cooking should be brought by the participants themselves, including water, only working table will be provided.
- Dishes should be purely vegetarian.
- Participants should not bring ay cut, chopped or grates raw materials. They should process it on the spot within allotted time.
- Participants can bring non-electric equipment like mixer, chopper, juicer, grater etc.
- Readymade decorative items are not permitted.
- Participants should clean their respective work places after the competition.
- Participants should arrange separate glass, spoons and plates, similarly cutlery items for serving three judges.
- The evaluation will be based on the taste of the dish, nutritional level, hygiene and presentation, unique name of the dish.

The event gave a platform to the students to demonstrate their culinary knowledge and skills related to: developing and following a recipe, preparation of a dish, and displaying the dish before a judging panel where it will be evaluated on flavor, taste and palatability.

## Mimicry Competition:

Mimicry is an action or skill of imitating someone or something, especially in order to entertain. Five year 5<sup>th</sup> sem., students organized the Mimicry competition. Around 10 participants took part in this competition. Human beings often mimic or imitate others both consciously and unconsciously. Mimicry has social benefits. Imitating others helps build rapport between two people or bond together social groups. Whether it occurs consciously or unconsciously, in face-to-face interactions or online, copying someone or something is an implicit way of paying them a compliment. In order to get familiar with the concept of mimicry, Five year 5<sup>th</sup> sem., students had organized a Mimicry Competition.

## **Rules for Mimicry Competition:**

- Each student will be given one entry only.
- Marking will be based on Skill imitating, Variety of sound and voice, Presentation.
- Participants may mimic sound/voice of any animal, thing, person or altogether.

- They can mimic any celebrity (Sports person, Bollywood or any other star, politician etc.)
- Language is no bar but it shouldn't contain abusive or offensive language or content.
- Time limit is 4+1=5 minutes. Marks will be reduced for mimicry done exceeding the time limit.
- Judges evaluate performance based on accuracy, creativity, end audience engagement.

Mimicry plays a significant role in learning, particularly social skills and teaching students to mimic an animal paves the way for more distinct and faster conversing and remove stage fear. Their acts involved reciting famous dialogues, facial expressions and actions of the chosen personalities.

#### **Elocution competition:**

"An eloquent speech does not reach from the lips to the ears rather it reaches from heart to heart." With this thought in mind, the students of Five year 1<sup>st</sup> sem., organized this competition. Around 12 students took part in the competition. Elocution plays an important role in the formation, articulation and pronunciation of speech. It helps students to exhibit their oratory skills, overcome stage fear and promote public speaking. Elocution competitions help students to develop their self-expression and confidence. The competition was culminated by presenting flower to the Jury members followed by a few words of encouragement by them.

Rules for Elocution competition:

- The participants should participate solely.
- Pre-registration is mandatory.
- Medium of expression will be in Kannada or English.
- Each speaker will be allowed to speak for maximum 5 minutes i.e. 4+1.
- Topic of elocution will be announced one day before the event.
- The performance will be judged in one language.
- The sequence of speaker will be decided by a draw of lot.
- The decision of the judges regarding the result of the competition will be final and binding.
- The judging will be based on the command over speech, expression, articulation and vocabulary.
- The competitor is strictly prohibited of using any mode of electronic gadgets or any form of materials.

It was indeed astounding to see how beautifully participants had put up their thoughts, insights, humour and delivered the speech of consciousness which was fluent, erudite and articulate while being unscripted.

## **Up-Cycles:**

Up-cycling is a powerful tool in the fight against fashion waste. By repurposing old clothing into new, stylish pieces, up-cycling extends the life of textiles, reduces the demand for new resources, and minimizes the environmental impact of fashion production. Up-cycled art is essentially the practice of repurposing recyclable waste in order to turn it from something that is unwanted to a creative piece of genius, with this thought 3 years 5<sup>th</sup> sem., students had organized the event up-cycling competition. Around 6 members participated in this event and showed their creativity in offering products with unique designs and patterns.

#### **Rules of Up-cycles**

- The required waste material and stationery like scissor, thread, etc., should be brought by the participants.
- Waste material could be anything like tetra pack, bottles, newspapers, old utensils, jute material or any second hand items that otherwise would be thrown away.
- Sole participation is allowed. No helping hand.
- Time duration is one hour.
- Judging criteria: Creativity, Item usefulness, Complexity of the project.

## Fourth Day Events of Koustubha Law Fest

# Date: 22.02.2024

The formal ceremony of the fourth day of this Koustubha Law Fest was shaded with Green Colour dress code where the students, staff and everyone were dressed up with the pretty green colour of different shades. The day started with Debate competition. The primary objective of the Debate competition was to encourage participants to harness their Rigorous and Critical Thinking, Academic skills, Mental and Emotional maturity. The Debate Competition was organized by Three years 1<sup>st</sup> sem., students in a most enthusiastic way. Around 25 students took part in this event.

#### Rules for **Debate competition**:

- State the facts, not just your personal opinion. Anything related to Law or citation.
- Respect your opponents: healthy debates leave space for both sides to be heard.
- Speak, don't shout. Turning up the volume will not make your argument more convincing.
- Don't interrupt, while the other person is speaking.
- Tap in, if you would like to step forward with an idea, gently tap someone on the shoulder who is sitting on the bench. This signals that you are ready to take a turn without disturbing the debate.
- The team supporting the motion must not shift its point of view. ...
- If a speaker makes a statement, they must be able to provide evidence or reasons to support the statement.
- Facts presented in a debate must be accurate.
- Speakers may not bring up new points in a rebuttal speech.

To begin with, each participant spoke their mind on topics that led to a wide spectrum of contrasting views which were maturely tackled by the opponent team. Facts represented by participants were accurate and expressed in decency language. The event was concluded maturely.

## Mime Show Competition:

Mime is an art or a technique of portraying a character, mood, idea, or narration by gestures and body movements. Mime competition on the theme 'Social Awareness' was organized by Three years 3<sup>rd</sup> sem., students. The competition was adjudged under the criteria of story weaving, coordination, execution and overall effect. There were 5 teams and all of them performed wonderfully well. Participants depicted the theme with their magnificent dramatic performance, brilliant gestures and body movements, but we were

awestruck by the performance put up by each team as they spellbound the audience with their fabulous act portrayed with such ease and conviction. Rules for Mime Show Competition:

- A team of 8-10 members are allowed in a group.
- The act should not contain any dialogues or lip sync.
- Background music is allowed.
- The theme should not be announced and should only be conveyed through gestures and movement.
- Contestants will be disqualified if act contains any offensive disrespectful actions or gestures.
- Duration: Maximum time limit is 10 minutes
- Negative points for exceeding time limit.
- Properties are not allowed.
- Judgment will based on the novelty of the idea and decisions of the judges are final.

Mastering the use of facial movements to express emotions is essential to not only acting but to communication in general. Body Movements: How someone walks, sits, stands and holds themselves communicates a lot about who they are and how they feel. In mime, to show sadness, a student might walk slower and slouch. Overall it was a great show as each team tried their level best to leave the impact on the audience spreading social awareness.

#### Super Minute:

The event was diligently and successfully organized by Three years 3<sup>rd</sup> sem., students. It witnessed an overwhelming response of 81 participants and was a magnificent success. Super Minute games are one minute games which are fun activities requiring participants to complete a challenge within sixty seconds. Example includes Gravity game, Face the Cookie, Scoop It Up, There She Blows etc., attracted a huge crowd. These games make excellent team building activities since they require a few supplies and a short time to plan.

These challenges are similar to Minute to win it games. These games are examples of fun team building exercises for work, team meeting games, quick and fun office games, quick and fun office games, and team building games without much efforts. These ideas are ways to improve team cooperation in all the activities.

#### The way few games played are:

#### 1. Face the Cookie

Face the Cookie game is one of the best one minute party games. You only need a few tiny cookies. You can start by handing all players one cookie apiece. Then, instruct players to place the cookie on their forehead, ensuring that it does not fall over. Players will then use their facial muscles to move the cookie to their mouths. You can eliminate any participants who do not manage to move and eat the cookie within the one minute timeframe.

#### 2. Gravity Game

The Gravity Game is a simple game that adults and kids alike will enjoy. You need to pass two balloons to each player. Then, let participants blow out the balloons and set the timer. Players will toss the two balloons in the air and keep them up without using their hands. Since the gravity game may need participants to move around, get a large space that will accommodate all players.

### **BEST PRACTICE- II**

#### 1. Title of the practice: Mentorship Mechanism

#### 2. Objectives of the Practice:

- > To minimize dropouts
- > To improve performance
- > To reduce stress of the students through personal counselling.
- To Increase the participation of all students in the different activities conducted by the Institute.

The Mentoring system assigns a faculty member to every student. The faculty member is called the mentor for the student. The mentor plays the role of a personal mentor for the student in all matters. For the institute, the mentor is the first point of reference for all matters concerning any specific student. The mentor guides the student at every step of their stay at the institute to be successful at whatever the student takes up. The mentor personally ensures that the student is aware of all the resources available to the student during their course of study at the institute. The mentor is available to counsel the student in any matter of concern apart from the curriculum also.

#### **3.** The Context

Students undergo various problems of stress- personal, academic, physical, mental. Students are new to professional college life. It creates a lot of stress, especially to hostel students who are away from family for the first time. Students from educationally weak background feel complex and hesitations in class and unable to perform well due to inhibitions. The Mentoring system is relatively new in general to a student entering the institute. The students do take some time to familiarize and feel more comfortable with their mentors and most importantly develop confidence in them. The students meet their mentors to consult with them regarding the courses to take and to guide them through the registration process. The students might also choose to meet their mentors more regularly for advice regarding matters which may be extra- or co-curricular or otherwise. In addition, the mentor might also choose to see any student with more regularity when their academic performance concerns the mentor.

#### 4. The Practice:

- Each teacher is assigned around 60-65 students for the complete duration of their study.
- They meet at least once a month to discuss, clarify and share various problems which may be personal or academic, etc.
- The mentors encourage the students to participate in co-curricular and extracurricular activities and sports.
- > The mentors also counsel the students in need of emotional problems.
- Mentors take special care of weak students, who are given advice on how to study, prepare a time table for study and clarify the doubts and also given notes to study
- Student problems are discussed in the staff meeting with other faculties and necessary action taken to solve it.

A mentor is the first point of reference for the activities of a student during the complete course of study at the institute. As soon as a student enters the institute, a faculty member is assigned to take over the role of a mentor for the student. The mentor not only guides the student in academic matters but also any matter of concern for the student. The student seeks the advice of the mentor at every step of their course of study beginning from the registration for courses at the start of every semester. The students meet their mentors regularly. However, depending on the need, mentor conducts more meetings with their students. The mentor educates the student about the various course requirements, such as the mandated minimum and maximum course load every semester, and how to choose electives.

The mentor helps the student channel their interests and energies effectively during the complete course of study at the institute. The students meet their mentors for various reasons, like - extra help with the material in a course and are shy to approach a new instructor assigned to the course. Few might be facing problems adjusting to the new environment may be in the hostel or at other places around the institute; some others would like to know about their options of availing various resources at the institute. Students would like to know about their options for going through internships during the break or even the benefits of the same, few might want to do some clinical course work or participate in various competitions in addition to their courses, some other might want to know their options after graduation and how to figure out where they would fit in better. At times the students might just need someone who can give them personal time and attention by listening to their struggles in transitioning to a higher education environment and finally in becoming a constructive member of society.

#### 5. Evidence of success:

The most important evidence of success for the mentorship program is the behaviour of the students on the campus in general has witnessed a tremendous improvement and the students are much happier and contended with their course of study at the institute after the implementation of the mentorship program. The pass percentage and the average academic performance of the students have also achieved greater heights with the mentoring system. Some students have presented themselves as quite a challenge for their mentors, but they figure out their priorities and start performing better after counseling sessions with their mentors. The students have been at most risk during their initial Stages in the course of study. The mentoring system has addressed the needs of the students and effectively nurtured many students during the duration of its implementation. Apart from these, there is an improved attendance, less drop outs, increased participation in co-curricular and extra-curricular activities, better discipline on campus and respectful relationship between teachers and students. The students are more relaxed and have a healthy relationship with the staffs.

#### 6. Problems Encountered and Resources Required

There were initial problems in creating mentorship programme. One challenge was identifying mentor mentee compatibility. Another major problem revolved around creating a system for interacting student with mentor in the institution. There were also instances where faculty failed to understand the level of student understanding in the class room where mode of teaching is not satisfactory for student to understand. Resources required which supports for mentoring like mutual contact, group discussions, meeting with parents, software tools, audio, video lecture systems are Incorporated.
