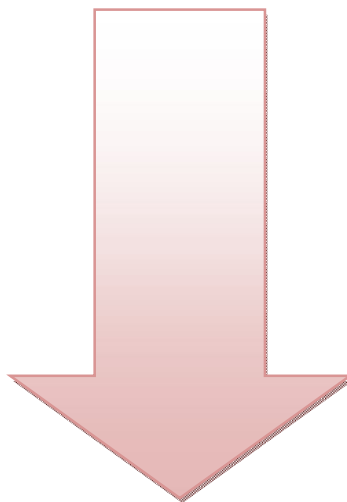

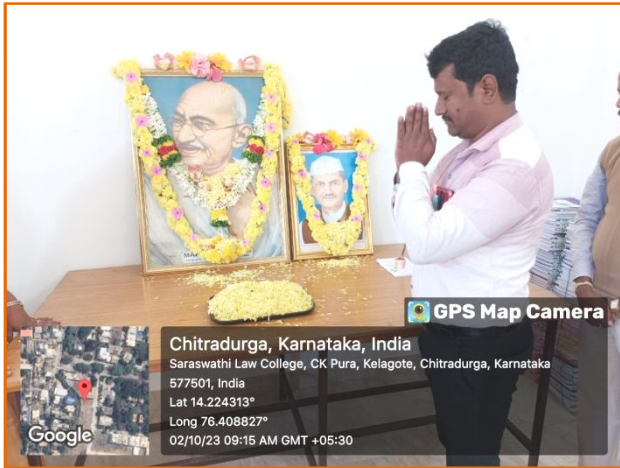

Report of Awareness Programme on the occasion of Constitution Day

Date: 27.11.2023

The Institution has organized Constitution Day celebration on 27th November 2023. The objectives of the programme is to create awareness about Constitution to sensitize the students and public about importance of Constitution Day.

The programme began in the ground after the assembly took over, by Oath taking ceremony carried by Shri. P.C. Murugesappa, Physical Education Director. It was followed by plantation drive as a symbol of National Environmental Awareness Month.

On this occasion an awareness programme was arranged by the Institution in association with District Legal Services Authority and Advocates Association, Chitradurga at 9:45am in Vakeelara Bhavana, Chitradurga. This programme began with the State Anthem record. It was followed by welcome speech and inauguration through showering flowers to Dr. B.R. Ambedkar and Mahathma Gandhiji's portraits by all the dignitaries on the dais.

The key note address was delivered by Shri. M. Vijay, Member Secretary, District Legal Services Authority, Chitradurga. It was followed by inaugural speech. Hon'ble Shri. Kemparaju, Principal Senior Civil Judge and CJM, Chitradurga preached the preamble of the India Constitution, which was recited by the gathering. In his speech he said that this programme is to cherish the glory and reaffirm our commitment to honour the ideology of Great Indian Constitution. The sole object of this programme is to understand the value of Constitution and spread it to the future generation. The Constitution inspired to live in unity and peace. To lead a satisfactory life one should read, understand and adopt the Constitutional Principles.

Shri. S. Vijaykumar, Advocate, Chitradurga delivered lecture on "Significance of Preamble". He said that the aims and aspiration of Constitution is Preamble as discussed under Keshavananda Bharathi case. He concluded by saying that advocates are the guardians of the Constitution.

The Preamble is aiming to secure, justice, liberty, equality to all citizens and promote fraternity to maintain unity and integrity of the nation, these were stressed in her speech.

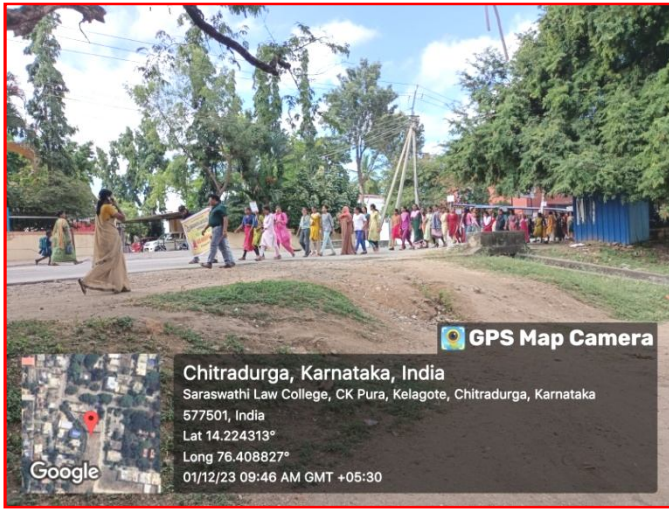

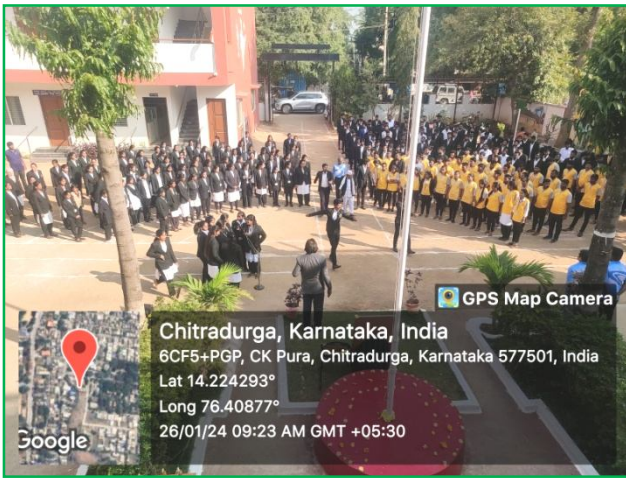


The programme was inaugurated by Naadoja Dr. Woode P. Krishna, President, Karnataka Gandhi Smaraka Nidhi, Bengaluru and other dignitaries of the dais. It was followed by Inaugural speech. He said that Mahatma Gandhiji's principles initiates a revolution that took the whole of nation in its stomp and lasted till we were able to get independence. This value system gave the nation the principles of truth, non-violence, satyagraha which result in people's heart. We are still alarm by the uniqueness of Gandhiji's principled approach. He endorsed simple living and high thinking while practicing. At present political, economic, social and moral rights as well as values are going down and exploiting. In the course of development we have to think of these problems and try to find out the solutions best suited to our needs. The best suited solutions for the above problems of contemporary world are to follow Gandhi's principles. It is Gandhi's philosophy can save us from this predicament. Gandhi's profuse writings, speeches and talks cover every conceivable aspects of Indian life of his time as well as present world. He delivered a valuable speech which inspired the students towards the five policies of Gandhiji i.e. Non-Violence, Satyagraha, Anti corruption, Education liberty, Decentralization in Democracy.

Sri. Vemagal Somashekar, Gandhivadi he gave brief information about the Gandhiji's visit to Karnataka, how Gandhiji used to motivate the youth towards his principles of unity in diversity and other said concepts. When Mahatma Gandhi was leading the nation towards its freedom, he had toured along the length and breadth of the country to gather people's support. He had visited Karnataka 18 times during the freedom struggle, and this establishes his special bond with the state.

Sri H. Hanumanthappa, President, Saraswathi Education Society ®, Chitradurga gave his presidential remark by focusing on Gandhi believed in the total development of the human personality through education. He advocated that education should start with hand. His emphasis was more on

3H's (head, heart and hand) than on 3R's (reading, writing and arithmetic). His concept of education means "an all-round drawing out of the best in the child and man-body, mind and spirit". He viewed education as a quest for truth and non-violence. Gandhi Meaning of Education emphasized the craft-centered education. Gandhi said that "literacy should never be the end of education nor even the beginning. It is only one of the means whereby man and women can be educated". He felt that true education calls for a proper exercise and training of the bodily organs and mental faculties. Gandhi gives importance both of individual and society.

Scholarship of under NSS Unit was distributed to the students and further the programme was concluded by vote of thanks delivered by Sri P.C. Murugeshappa, Physical Education Director. Around 250 students took part in the programme and got inspired by the thought provoking speeches.

Date: 06.02.2024

In view of World Cancer Day which was celebrated on February 4th every year all over the world, the Institution conducted health awareness programme for the students on 6th February in Saraswathi Law College Campus under the theme 'Close the Care Gap'. Sri P. C. Murugeshappa, Physical Education Director gave an introductory speech on importance of World Cancer Day, he said Cancer is a condition in which some cells in the body develop uncontrollably and spread to other parts of the body. Globally, cancer is the leading cause of mortality, accounting for over one crore deaths in 2020. In India, the incidence rate was reported between 19 and 20 lakhs (estimated cases in 2022). Usage of Tobacco, prolonged consumption of alcohol, unhealthy food habit, lack of physical exercise and exposure to air pollution are all risk factors for cancer.

Prof. Dr. M. S. Sudhadevi, Principal, Saraswathi Law College, Chitradurga, gave a talk on What is CANCER? and Its Risk factors and she also gave a brief information on Common types of cancer in INDIA. She also said that general awareness of cancer screening, prevention, and treatment is low among the Indian and global populations, especially in low and middle-income with poor literacy rates leading to an increase in cancer prevalence, and there is an urgent need to fill the lacunae with proper education. World Cancer Day brings attention to how important it is to prevent cancer, find it early, and treat it. The programme was dissolved by proposing vote of thanks. Around 100 students took part and benefitted by this short awareness programme.

- It will help the situation to get worse in terms of halting the progress from less severe form to more severe form;
- It will help in overcoming the trauma caused by the abuse;
- It will prevent sexually transmitted diseases and unwanted pregnancies; early reporting will help in speedy processing and early justice;
- It will help in separating the perpetrator from the victim and reduce the risk of repetition of the offence;
- Lowers the severity of long-term psychological impact on the victim.

The programme concluded with the presidential remark delivered by Headmistress Smt. Divya, Kote High School, Chitradurga, She said Keeping in view the growing imbalance in the man-woman ratio, we have to emphasize focusing on celebrating and welcoming girl child. To get rid of vicious social customs of dowry system responsible for killing of girl child, the status of women shall have to be enhanced.

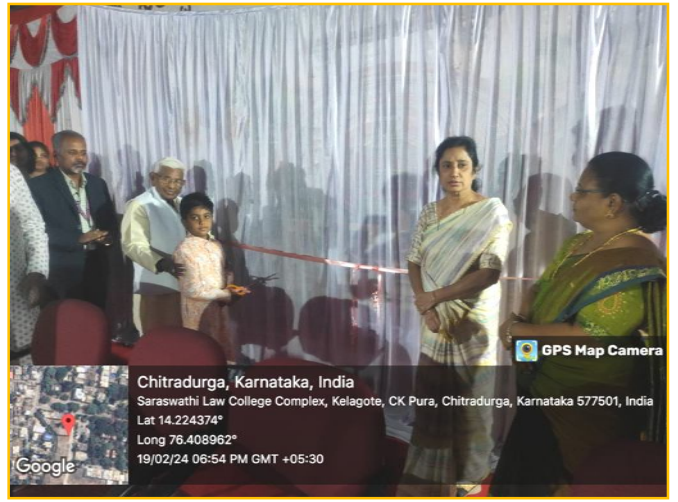

Students were instructed with certain rules and regulations such as:

Third Day Events of Koustubha Law Fest

Date: 21.02.2024

On the third day the maximum students were dressed up with yellow colour dress code and began the program with full of energy and dedication. The day commenced with Dumb Charades. Five years 5th Sem B.A.LL.B students organized this event. Around 26 participants participated in an event. Dumb charades is a fun activity where participants have to act out a word or phrase without speaking, and the other participants have to guess what it is. To make the students more clear about the action and in order to bring out their hidden talents and showcase their acting skills this event was arranged.

Rules for **Dumb Charades**:

- Two members in a group.
- The performance has to be silent with no words as the word 'dumb' goes.
- The player has to use facial expression, gestures and body language.
- Clues like lip-reading, humming songs, pointing and spelling are banned.
- Language, number of words must be said at first.
- There is a particular time limit for teams to guess i.e. 60 seconds.
- There will be four rounds in this event like Proverb round, Word guess round, Legal term round, Films and actor personalities round.

Cooking without fire, Elocution and Mimicry competitions were commenced in different class rooms simultaneously. Cooking without fire competition was organized by Five years 1st sem., students in a most systematic way. In all 27 students participated wholeheartedly in the event. Their efforts were evaluated on the basis of five parameters: i) Dish name, ii) Taste, iii) Presentation, iv) Calorie content and v) Hygiene. Participants infused lots of creativity and served delicious eatables to enhance the taste buds. Here the participant had to prepare an eatable without using the fire. So the participants served plates of Bhel puri, Chaat, andwiches, shakes, Mojito, Chocolate lollypop Dry fruits laddu and many more.

Rules of **Cooking without fire**:

- One team may contain a maximum of 2 members.
- Pre-registration is mandatory.
- Total preparation time – 40-45 minutes.

- All the items required for cooking should be brought by the participants themselves, including water, only working table will be provided.
- Dishes should be purely vegetarian.
- Participants should not bring any cut, chopped or grates raw materials. They should process it on the spot within allotted time.
- Participants can bring non-electric equipment like mixer, chopper, juicer, grater etc.
- Readymade decorative items are not permitted.
- Participants should clean their respective work places after the competition.
- Participants should arrange separate glass, spoons and plates, similarly cutlery items for serving three judges.
- The evaluation will be based on the taste of the dish, nutritional level, hygiene and presentation, unique name of the dish.

The event gave a platform to the students to demonstrate their culinary knowledge and skills related to: developing and following a recipe, preparation of a dish, and displaying the dish before a judging panel where it will be evaluated on flavor, taste and palatability.

Mimicry Competition:

Mimicry is an action or skill of imitating someone or something, especially in order to entertain. Five year 5th sem., students organized the Mimicry competition. Around 10 participants took part in this competition. Human beings often mimic or imitate others both consciously and unconsciously. Mimicry has social benefits. Imitating others helps build rapport between two people or bond together social groups. Whether it occurs consciously or unconsciously, in face-to-face interactions or online, copying someone or something is an implicit way of paying them a compliment. In order to get familiar with the concept of mimicry, Five year 5th sem., students had organized a Mimicry Competition.

Rules for Mimicry Competition:

- Each student will be given one entry only.
- Marking will be based on Skill imitating, Variety of sound and voice, Presentation.
- Participants may mimic sound/voice of any animal, thing, person or altogether.

- They can mimic any celebrity (Sports person, Bollywood or any other star, politician etc.)
- Language is no bar but it shouldn't contain abusive or offensive language or content.
- Time limit is 4+1=5 minutes. Marks will be reduced for mimicry done exceeding the time limit.
- Judges evaluate performance based on accuracy, creativity, end audience engagement.

Mimicry plays a significant role in learning, particularly social skills and teaching students to mimic an animal paves the way for more distinct and faster conversing and remove stage fear. Their acts involved reciting famous dialogues, facial expressions and actions of the chosen personalities.

Elocution competition:

“An eloquent speech does not reach from the lips to the ears rather it reaches from heart to heart.” With this thought in mind, the students of Five year 1st sem., organized this competition. Around 12 students took part in the competition. Elocution plays an important role in the formation, articulation and pronunciation of speech. It helps students to exhibit their oratory skills, overcome stage fear and promote public speaking. Elocution competitions help students to develop their self-expression and confidence. The competition was culminated by presenting flower to the Jury members followed by a few words of encouragement by them.

Rules for Elocution competition:

- The participants should participate solely.
- Pre-registration is mandatory.
- Medium of expression will be in Kannada or English.
- Each speaker will be allowed to speak for maximum 5 minutes i.e. 4+1.
- Topic of elocution will be announced one day before the event.
- The performance will be judged in one language.
- The sequence of speaker will be decided by a draw of lot.
- The decision of the judges regarding the result of the competition will be final and binding.
- The judging will be based on the command over speech, expression, articulation and vocabulary.
- The competitor is strictly prohibited of using any mode of electronic gadgets or any form of materials.

It was indeed astounding to see how beautifully participants had put up their thoughts, insights, humour and delivered the speech of consciousness which was fluent, erudite and articulate while being unscripted.

Up-Cycles:

Up-cycling is a powerful tool in the fight against fashion waste. By repurposing old clothing into new, stylish pieces, up-cycling extends the life of textiles, reduces the demand for new resources, and minimizes the environmental impact of fashion production. Up-cycled art is essentially the practice of repurposing recyclable waste in order to turn it from something that is unwanted to a creative piece of genius, with this thought 3 years 5th sem., students had organized the event up-cycling competition. Around 6 members participated in this event and showed their creativity in offering products with unique designs and patterns.

Rules of Up-cycles

- The required waste material and stationery like scissor, thread, etc., should be brought by the participants.
- Waste material could be anything like tetra pack, bottles, newspapers, old utensils, jute material or any second hand items that otherwise would be thrown away.
- Sole participation is allowed. No helping hand.
- Time duration is one hour.
- Judging criteria: Creativity, Item usefulness, Complexity of the project.

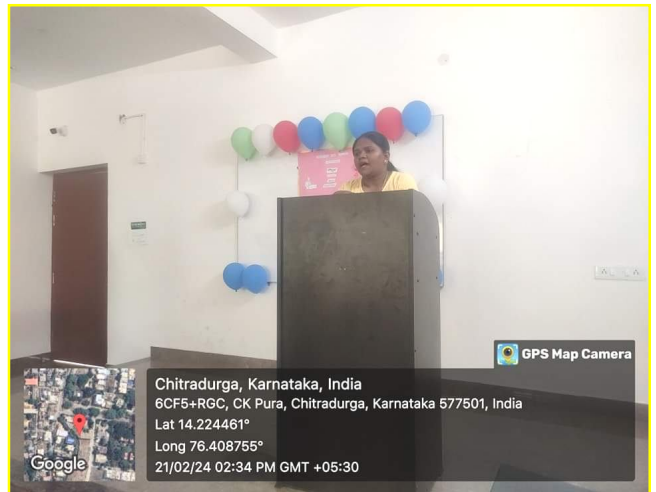
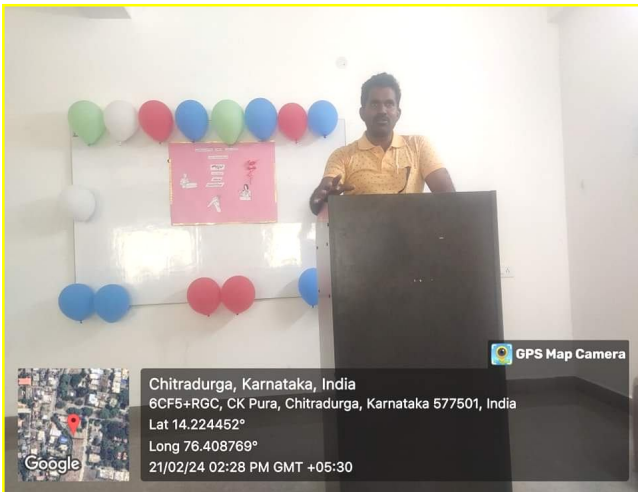

Fourth Day Events of Koustubha Law Fest

Date: 22.02.2024

The formal ceremony of the fourth day of this Koustubha Law Fest was shaded with Green Colour dress code where the students, staff and everyone were dressed up with the pretty green colour of different shades. The day started with Debate competition. The primary objective of the Debate competition was to encourage participants to harness their Rigorous and Critical Thinking, Academic skills, Mental and Emotional maturity. The Debate Competition was organized by Three years 1st sem., students in a most enthusiastic way. Around 25 students took part in this event.

Rules for **Debate competition:**

- State the facts, not just your personal opinion. Anything related to Law or citation.
- Respect your opponents: healthy debates leave space for both sides to be heard.
- Speak, don't shout. Turning up the volume will not make your argument more convincing.
- Don't interrupt, while the other person is speaking.
- Tap in, if you would like to step forward with an idea, gently tap someone on the shoulder who is sitting on the bench. This signals that you are ready to take a turn without disturbing the debate.
- The team supporting the motion must not shift its point of view. ...
- If a speaker makes a statement, they must be able to provide evidence or reasons to support the statement.
- Facts presented in a debate must be accurate.
- Speakers may not bring up new points in a rebuttal speech.

To begin with, each participant spoke their mind on topics that led to a wide spectrum of contrasting views which were maturely tackled by the opponent team. Facts represented by participants were accurate and expressed in decency language. The event was concluded maturely.

Mime Show Competition:

Mime is an art or a technique of portraying a character, mood, idea, or narration by gestures and body movements. Mime competition on the theme 'Social Awareness' was organized by Three years 3rd sem., students. The competition was adjudged under the criteria of story weaving, coordination, execution and overall effect. There were 5 teams and all of them performed wonderfully well. Participants depicted the theme with their magnificent dramatic performance, brilliant gestures and body movements, but we were

awestruck by the performance put up by each team as they spellbound the audience with their fabulous act portrayed with such ease and conviction.

Rules for Mime Show Competition:

- A team of 8-10 members are allowed in a group.
- The act should not contain any dialogues or lip sync.
- Background music is allowed.
- The theme should not be announced and should only be conveyed through gestures and movement.
- Contestants will be disqualified if act contains any offensive disrespectful actions or gestures.
- Duration: Maximum time limit is 10 minutes
- Negative points for exceeding time limit.
- Properties are not allowed.
- Judgment will based on the novelty of the idea and decisions of the judges are final.

Mastering the use of facial movements to express emotions is essential to not only acting but to communication in general. Body Movements: How someone walks, sits, stands and holds themselves communicates a lot about who they are and how they feel. In mime, to show sadness, a student might walk slower and slouch. Overall it was a great show as each team tried their level best to leave the impact on the audience spreading social awareness.

Super Minute:

The event was diligently and successfully organized by Three years 3rd sem., students. It witnessed an overwhelming response of 81 participants and was a magnificent success. Super Minute games are one minute games which are fun activities requiring participants to complete a challenge within sixty seconds. Example includes Gravity game, Face the Cookie, Scoop It Up, There She Blows etc., attracted a huge crowd. These games make excellent team building activities since they require a few supplies and a short time to plan.

These challenges are similar to Minute to win it games. These games are examples of fun team building exercises for work, team meeting games, quick and fun office games, quick and fun office games, and team building games without much efforts. 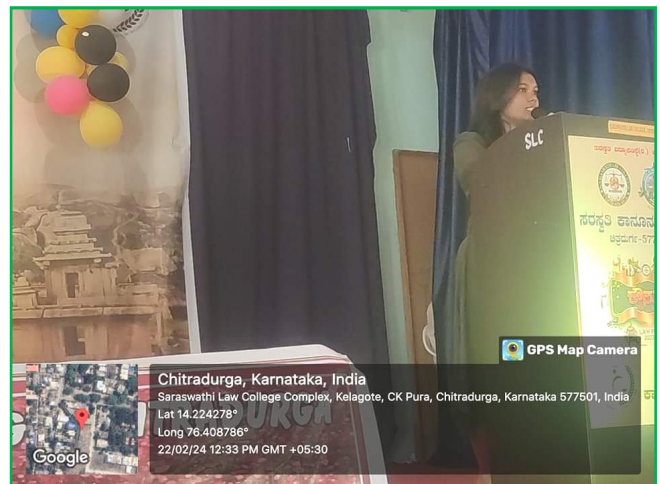
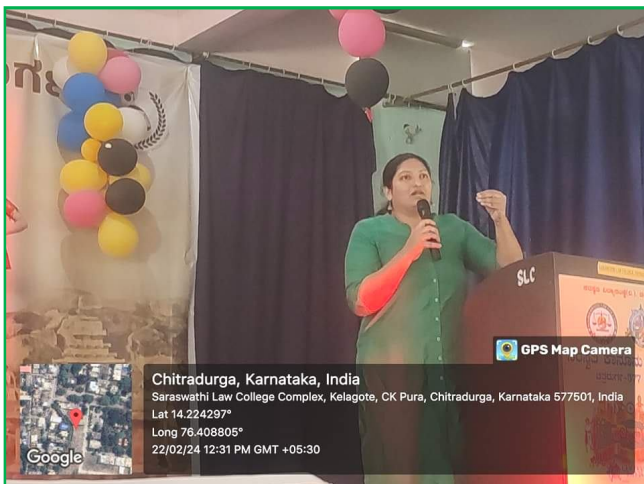
The way few games played are:

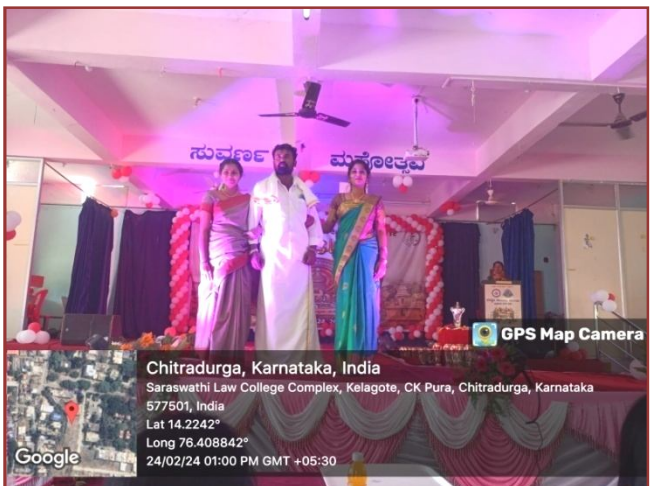

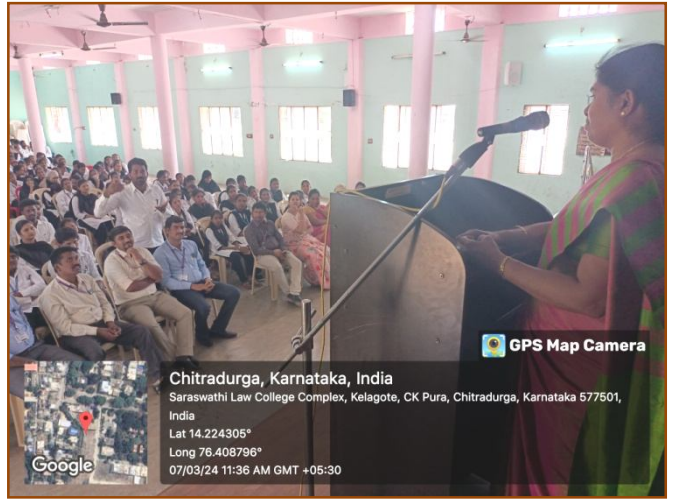

Report of Workshop on New Criminal Laws

Date: 18.05.2024

In Collaborative effort Saraswathi Law College and Police Training School, Aimangala, a One Day Workshop on recently amended or modified Criminal Laws (BNS, BNSS and BSA) was organised at Saraswathi Law College, Golden Jubilee Auditorium on Saturday.

The Programme was commenced by Sri P. C. Murugesappa, Physical Director, Saraswathi Law College, Chitradurga. The programme begun with blessings of almighty god through invocation sung by Bhoomika G.R of 5 years 3rd year B.A.LL.B., student.


Dr. Kariyanna. K.S, Assistant Professor, Saraswathi Law College, Chitradurga delivered the welcome speech. Shri Krishna Naik A, Police Inspector, Police Training School, Aimangala Inaugurated the Workshop, emphasising that it aimed to enhance capabilities of law students through detailed explanation of New Criminal Laws and the process involved in the implementations.

In the first session he discussed the topic 'What has been included and What has been left behind'.

In the second session Prof. Dr. Nataraja, Retd., Professor, Department of Criminology, Chitradurga, shared his insights on 'Fundamental Changes in New Laws' while highlighting the need of new criminal laws. He said that the earlier laws were largely influenced by the colonial mindset and lacked the humanist approach, while the new laws are based on humanist values and are victim centric. These new laws allow the use of technology in dealing with crime and provide for the time bound disposal of cases.

In the third session Prof. Dr. M. S. Sudhadevi, Principal, Saraswathi Law College, Chitradurga expressed that Criminal law is one of the most crucial branches of law. As it directly impact day to day human behaviour, it is a branch of law that manifest the relationship between state and its citizens. Since time immemorial societies around the world have observed a prescribed code of conduct. Indian Penal Code, 1860 occupies a predominant place amongst the laws designed as agencies of social control. Although crucial amendments have also been made from time to time to adapt these legislations to social, economic and technological changes, the amendments have proved insufficient in creating a robust criminal administrative system which is well equipped to meet the peculiar challenges of contemporary times.

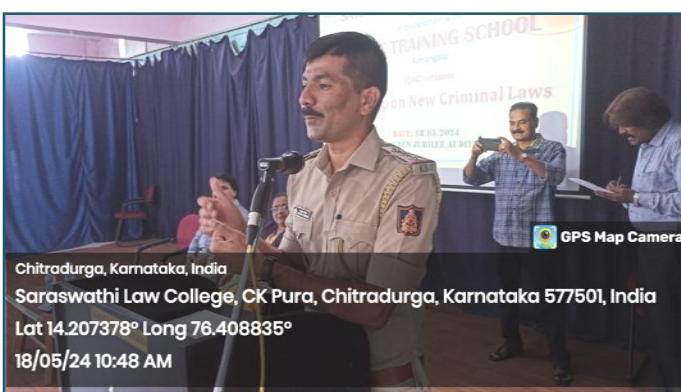

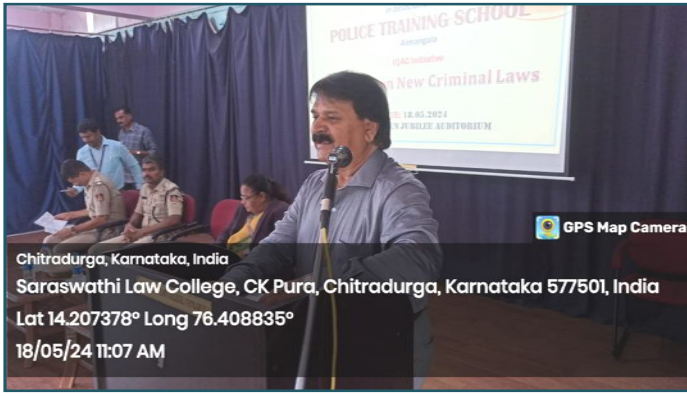

Refreshments were served after the programme. The event was a success in every respect. It was a great experience for the players and other students in audience.

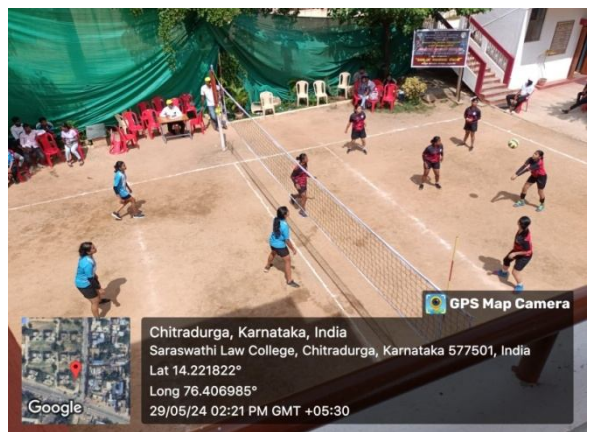

Report of State Level Workshop on New Criminal Major Acts: Changes and Impact on Criminal Justice

Date :07.06.2024

The institution gave an opportunity to attend State Level Workshop for the criminal laws subject teachers and two students to upgrade the knowledge with respect to the new criminal major acts, for this they have visited Shivamogga to National College of Law and Centre for Post Graduate Studies In Law, Shivamogga in Association with Alumni Association of CBR National College of Law Shivamogga had organised state level workshop on "New Criminal Major Acts :Changes and Impact on Criminal Justice". For creating awareness on the new Three criminal laws, namely The Bharatiya Nyaya Sanhita, 2023(BNS); The Bharatiya Nagarik Suraksha Sanhita, 2023(BNSS) and The Bharatiya Sakshya Adhiniyam,2023(BSA) repealing The Penal Code,1860 The code of criminal procedure,1973 and The Evidence act, 1872.

In the Inaugural address delivered by Manjunath Nayak, Principal Dist And Session Judge, Shivamogga., he said that the new three criminal laws are the watershed moment of our society, because no law affects the day to day conduct of our society like criminal law. He also said judge made laws are being changed into parliament made law.

P. Narayan Director of National College of Law talked about the changing landscape of India and said the essentiality of the awareness regarding new criminal laws. Dr.Anala, Principal CBR National College of Law Shivamogga set the tone for the conference and introduced the theme of the conference, she said that this is a journey of enlightenment and exploration into the heart of one of the India's most crucial endeavours, the transformation of the criminal justice system.

In the first session Sri H.D Ananada Kumar Retd., Public Prosecutor Advocate Mysuru said that BNS has brought in significant changes in substantive criminal law, while retaining a substantial part of penal code ,1860. The BNSS, introduces on the otherhand,sweeping changes in the procedure designed to galvanise India's justice system through the imposition of strict timelines for various stages and aspects of investigation, enquiries, trial, judgements and appeals as also by the introduction of liberal use of the electronic medium to enhance its efficacy. It is victim friendly and gives opportunities to accused of fair representation. He discussed the chapterisation of the BNS. He highlighted that the problem of complicated and scattered chapters under the IPC has been resolved and discussed how

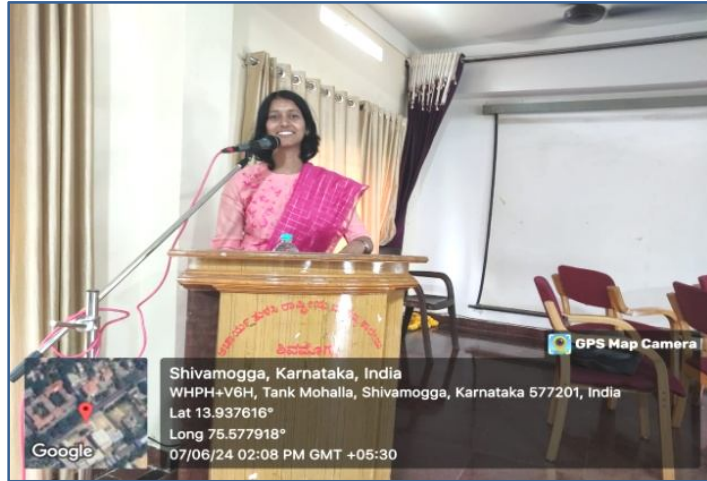
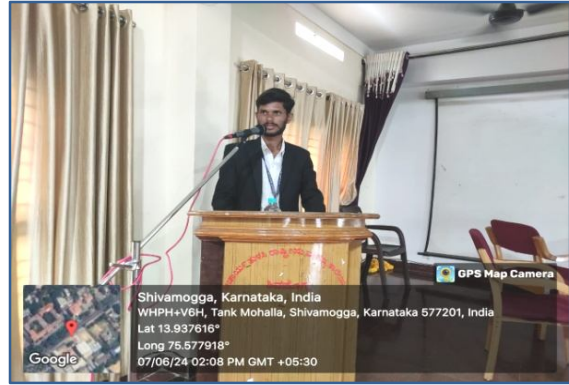
the chapter five of the BNS consolidates the offences relating to women and children at one place, which were previously scattered under four separate chapters of the IPC. He also said that arrangement of offences is in the manner, which is easily understood to layman. All the major reforms, significant judgements in the past 75 years have been included in the BNS.

The Chairman of first session Pramath Adiga spoke on the occasion by highlighting that the change is not about mere changing the scheme of the Act but to include the perspective of a common citizen.

In the second session Sri H.D Ananada Kumar Retd., Public Prosecutor Advocate Mysuru while discussing the scheme of punishment, he said that earlier the shift was from Deterrent to Retributive, but now the change is from Retributive to Reformative. While discussing the implementation of this newly introduced punishment, he highlighted the six offences, for which the community service has been prescribed. Quoting from Mahabharata- "I know what dharama is, but I cannot walk on that path", he said that the socio economic condition and psychology of a person influences their criminal behaviour and he concluded by saying that time is the test for these increased punishments, as to how effectively they will reduce the crime, deterrence, alone, is not sufficient.

The chairperson of the program in the second session Sri Krishna Rao narrated the striking balance between over criminalisation and decriminalisation, stated that criminality is like gunpowder lying harmless in the gun, unless it is ignited by some external acts. He discussed some important deletions, such as section 377, 124A, 309, etc. In respect to over-criminalisation, he said that the hit and run matters, has been recognised and it is a laudable move that the same has been put under section 106 of the BNS and the punishment is enhanced to 10 years.

Few audience expressed their opinion about the workshop by conveying the effectiveness and knowledgeable information delivered by the speakers. The programme was dissolved with the vote of thanks delivered by Mrs. Anupama assistant professor, CBR National College of Law Shivamogga.

Santosh Hegde, addressed the gathering by informing the students when and where the prefix are to be used for the name and cited the Supreme Court case law which holds good regarding the matter. He also cited examples of specific cases where he witnessed corruption in administration from various forms of public services. “We cannot blame individuals because this fault lies with society. Earlier, there was social centralization of criminals; and role of families, parents and moral science education were significant in shaping our minds. But today, the social fabric itself has changed. Unfortunately, today’s society respects only money and power, while honesty often takes a backseat.”

“Only education cannot give value to the society. Our objectives and attitudes should also be good. When the students become employees in future, they should fight against the corruption. Corruption is rampant in all the four pillars of the Constitution like Legislature, Executive, Judiciary and Media. It's unfortunate that there are no serious discussions and debates in Parliament and Assembly. Our elected representatives have been spending time in meaningless debates or commotions. As a result, public money is being wasted”, he said.

He reminded some of the major scams to have plagued our country for the past few decades and as to the huge amounts of public money that were siphoned off from administration. "Such people are not afraid of law. No one wants to bring about change and blame game becomes the order of the day. Where is democracy and how can true development happen in this kind of a situation? What is the way out of this to bring about peace and solidarity of the nation?" he left the question open to the audience.

He also spoke about the mining report that he authored which was released in 2011, saying his recommendations were not implemented by successive governments. "The only way out of this rut of ever-increasing greed is inculcating a value of contentment. Be content with what you legitimately have. I know a lot of dedication and determination is required for this. But once it is accomplished, any amount of temptation can be countered."

His talk was followed by a Q&A session with the audience, during which he suggested that to fight when the system itself is choked, people within and outside the system should be willing to change. "The time has come to reduce the number of appeal forums and thereby speculative litigation, which will result in quicker decisions by the Judiciary."

To another query about making policies more people-centric, he suggested, "Confine the Supreme Court for constitutional matters only. For policy matters a different forum should be created. Around 25 questions were posed by the students and all those were answered in a most zealous and patience manner by Hon'ble Justice Shri. N. Santosh Hegde. Further more questions from students were waiting in a queue, but due to time constraints it was necessary to end the program.

Felicitation was made to Hon'ble Justice Shri. N. Santosh Hegde by Sri Fathyarajan, Senior Advocate, Vice President, Saraswathi Education Society, Chitradurga, and Smt. D. K. Sheela, Senior Advocate, Secretary, Saraswathi Education Society, Chitradurga, with Shawl, Garland, Fruit box, Memento. Student Law Forum members also felicitated Hon'ble Justice Shri. N. Santosh Hegde with Shawl and memento.

Dr. K. S. Kariyanna, Assistant Professor, Saraswathi Law College, Chitradurga proposed Vote of thanks. The program was winded up by singing National Anthem in chorus. More than 300 students were benefitted by this program.

Report on creating Awareness about POCSO Act and The Prohibition of Child Marriage Act among school Children

Date: 28.08.2024

The Institution Organized an awareness programme on POCSO Act and Child Marriage in Agasanakallu Government School, Chitradurga on 28th August 2024. The Protection of Children from Sexual Offences Act, 2012 for short POSCO Act and The Prohibition of Child Marriage Act 2006 is an important concept to be sensitized to the children, because Schools are environments where children spend a significant amount of their time. Awareness will ensure that children are protected from sexual offences at school. Educating students about their rights and how to recognize and report abuse can empower them to protect themselves and others

The programme was compared by Smt. Manjula. M. R, Social Teacher Agasanakallu High School, Chitradurga. It began with a warm welcome speech delivered by Sri Karibasappa. K, Hindi Teacher, Agasanakallu High School, Chitradurga.

The resource person of the programme was Prof. Dr. M. S. Sudhadevi, Principal, Saraswathi Law College, Chitradurga. She raised awareness on good touch and bad touch and highlighted the POSCO Act. She further informed that even the death penalty can be awarded for committing sexual crimes on children. Considering the gravity of sexual crimes on children, she exhorted the children to report such cases to the Parents or Teachers or the person whom they trust so as to bring a complaint to the police station to award stringent punishment to the perpetrators as per law.

Smt. Harsha. S. M., Assistant Professor, Saraswathi Law College, Chitradurga addressed the gathering and said Child Marriage is a toxic that ruins young lives. Many a time, early marriages are done to bring child brides into forced household chores. This has a serious burden on young girls which leads to health, safety, bodily integrity and self determination issues. She also quoted that many are not even aware of the correct legal age of marriage for girls and boys. Thus, awareness within the community is very much required. She made the program more interesting by explaining

how children and parents will be trapped to child marriage with a short story. She explained the topic by putting different examples. The children were also informed about child Help line-1098 and 112 and advised to report any case of child abuse or child marriage or any trouble.

Smt. Uma Maheshwari, Head Mistress, Agasanakallu Middle School, Chitradurga addressed the gathering and said that the child victim of sexual offence could be a boy or a girl both can seek a protection under POCSO Act and the offender too can be male or a female both can be punished alike. Regarding child marriage the law is armed with enabling provisions to prohibit child marriage, protect and provide relief to victim and enhance punishment for those who abet, promote or solemnize such marriage.

Sri Thippeswamy H. M. HeadMaster, Agasanakallu High School, Chitradurga delivered the presidential address and said that this awareness programme aimed to educate students about the laws and empower the children to identify signs of abuse or coercion and raise their voice against wrong activities made to them and be in a protective zone. He also highlighted that the parents and guardians should be aware of the provisions of the child welfare Acts in place for its effective implementation.

The programme was concluded by proposing vote of thanks by Sri Fayaz. K, Physical Education Teacher, Agasanakallu High School, Chitradurga.
