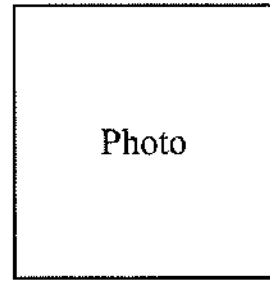

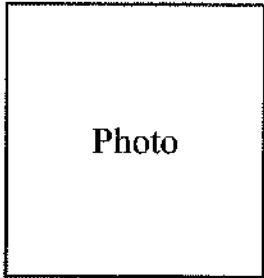

## SARASWATHI LAW COLLEGE

### Introduction:

Chitradurga is a Fort City known for its Rock Fort and pre-historic excavations at Chandravally on the outskirts of the city. Researchers in history have opined that it is in the later part of third century A.D, the founder of Kadamba Dynasty, Mayura Sharma had started his journey from this Chinmuladri hillocks of Chandravally, by mobilising the local tribal people into an army. The inscription at the Siddeshwara Temple has also been famous as 'ChandravallyInscription'.The city is well connected with rail-road facility and is about 200 kms away from Bengaluru, on the National Highway-4, to Mumbai. It is a backward district according to Prof. D.M. Nanjundappa Committee Report on Regional Imbalance.

The Saraswathi Education Society was established in the year 1964 with a prime objective of taking the legal education to the thresholds of socially and economically deprived students. In the same year, the Society started **Saraswathi Law College inaugurated by Morarji Desai, Former Deputy Prime Minister of India** as an initiative of learned senior advocates of Chitradurga Law Courts. It was the first Law College to be started in the integrated District of Chitradurga and Davangere, under the affiliation of erstwhile Mysore University. Later, when the Kuvempu University was started, it came into its folder. When the Government of Karnataka started the Karnataka State Law University in 2009, the Institution came under its affiliation. Now the Institution is functioning as an affiliated college of Karnataka State Law University recognised by the Bar Council of India and approved by the Government of Karnataka in the year 2015, the Institution was admitted into Grant-in-Aid by the Government of Karnataka. Since college completed 50 years of establishment in 2015 celebrated Golden Jubilee (SuvarnaSambhrama). Hon'ble H.L. Dattu, Chief Justice, Supreme Court of India was the Chief Guest of the Programme. Saraswathi Law College has been Accredited with 'B' Grade by NAAC during the year 2021.

In order to provide better infrastructure the Saraswathi Education Society constructed a new additional building "**Kanoonu Soudha**". The opening ceremony of the new building was organized on 23<sup>rd</sup> November 2022. The Hon'ble Chief Minister Shri. Basavaraj Bommai inaugurated the building. Shri. Govinda Karjal, Minister of Major & Medium Irrigation, Government of Karnataka, Shri. Byrathi Basavaraj, Minister of Urban Development, Shri. N. Ravikumar, M.L.C., Shri. K.S. ### Infrastructure :

Infrastructure is created as per the requirements of the statutory bodies that is, the UGC, Bar Council of India, Karnataka State Law University and the Government of Karnataka. It includes the campus building and physical qualities. The building has the Management Board Room, Principal Chamber, Administrative Block, Class Rooms having modern teaching aids, Digital Library, Reading Room, Moot Court Hall, Staff Room, Legal Aid Centre, Multi Gym with Sports Room, Auditorium, Computer Lab, Ladies Lounge, Gents Rest Room, Canteen and Vehicle Parking Shed. ICT facilities are provided in class rooms, office, auditorium and other places, wherever needed. The Yoga and Meditation practices are conducted periodically in the Institution's auditorium to inculcate the healthy habits to make the students physically sound and mentally alert. The Institution has a good Library with Books and Journals essential for students and faculty. Disabled Friendly Environment have been provided in the institution.

**Admission Eligibility:**

The enrolment of students in the Institution is according to norms of Government of Karnataka and the Karnataka State Law University. The reservation system is followed to ensure inclusiveness in the admission process as per the Government of Karnataka norms.

**The Admission for 3 Years LL.B. Course:**

- (a) Any degree in any discipline of knowledge from a University established by an Act of Parliament or by a State Legislature or an equivalent national institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence.
- (b) **Minimum percentage** of marks in qualifying examination shall not be less than 45% (44.5% and above shall be treated as 45%) of total marks in case of General category applicants, 42% (41.5% and above shall be treated as 42%) for OBC category and 40% (39.5% and above shall be treated as 40%) of total marks in case of SC and ST applicants.
- (c) **Maximum age\*** for seeking admission is limited to 30 years in case of General category of applicants and to 35 years in case of applicants from SC, ST and Other Backward Communities.

**Explanation :**

- (i) An applicant who has passed the 3 years U G degree from Open or Deemed University recognized by & established under the UGC Act, after prosecuting the studies in the pattern of 10+2 at Secondary/Higher Secondary Schooling is eligible for admission.
- (ii) The applicant who has passed the qualifying examination U.G.degree in a single sitting examination is not eligible for admission to 3 yr LL.B Law Course of KSLU, Hubballi.

**Admission for 5 Years B.A LL.B. Course:**

- (a) An applicant, who has successfully completed Pre-University course or Senior Secondary School course ('+2') or equivalent such as (11+1, 'A' level in Senior School Leaving Certificate Course) from a recognised University of India or outside or from Senior Secondary Board or equivalent, constituted or recognised by the Union or by the State Government or from any equivalent institution from a foreign country recognised by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course, may apply for and be admitted into the course.
- (b) **Minimum percentage of marks** in qualifying examination shall not be less than 45% (44.5% and above shall be treated as 45%) of total marks in case of General category applicants, 42% (41.5% and above shall be treated as 42%) for OBC category and 40% (36.5% and above shall be treated as 40%) of total marks in case of SC and ST applicants.
- © **Maximum age\*** for seeking admission is limited to 20 years in case of General category of applicants and to 22 years in the case of applicants from SC, ST and Other Backward Communities.

\* A Writ Petition (civil) No. 1023/2016 pending before the Supreme Court of India regarding the maximum age limit prescribed for admission. The admission of the students who have crossed the age limit is subject to the outcome of the said writ petition. In this regard, college has to obtain an undertaking from the students who have crossed the age limit in the proforma enclosed.

### Explanation :

Provided that the applicants who have obtained +2 Higher Secondary Pass Certificate or First Degree Certificate after prosecuting studies in distance or correspondence method shall also be considered as eligible for admission to 5 years LL.B., course.

Provided further that the applicants who have obtained 10+2 or graduation or post-graduation through open Universities system directly without having any basic qualification for prosecuting such students are not eligible for admission to the Law course.

## Specialization( Special Attention)

The Institution follows the Curriculum designed and delivered by the Karnataka State Law University. Besides the Curriculum delivered by the University the Institution take interest in conducting various add-on courses to imbibe additional skills and talents needed to transform the budding law graduates into creative professionals. The courses are:- Communication Skills Development (both English & Kannada) including Spoken English, Computer Skills, Soft Skills & Life Skill Developments, Personality Development, Yoga & Meditation Courses, for the development of physical attributes and mental concentration in students. Certificates will be issued to the students with Grade system in all Add-on courses.

From the point of view of imbibing these skills, the college timing has been extended form 9 Am to 6 Pm on all working days except on Sunday and Saturday. On Saturday remedial coaching classes are conducted for slow learners and failed students without any additional fees. For this purpose Remedial coaching Classes Committee is constituted. In all these classes, examination skills are taught, besides, solving old question papers. On all these days canteen facility is provided from morning till evening within the campus.

The internship programme is a part of the curriculum. Specific programmes on the gender equity, human values, professional ethics and social skills are conducted in Institution every year to imbibe specific value and skill in students and faculty. The lecture method is supported by seminar, symposium, group discussions, special lectures and field visits.

ICT facilities are provided in some of the class rooms, library and laboratory. The Karnataka State Law University examination branch conducts written examination at the Institution in every subject. The total number of marks earmarked per subject, treated as one paper, are 100-80 marks are for the written examination and 20 marks as internal assessment. The Institution has a Students Grievance Redressal Cell, which takes care of receiving and redressing the students grievances.
