All the faculty, staff, students and any other persons entering into the Institution have to observe strictly the following norms, the failing of which would be seriously viewed and action will be taken.

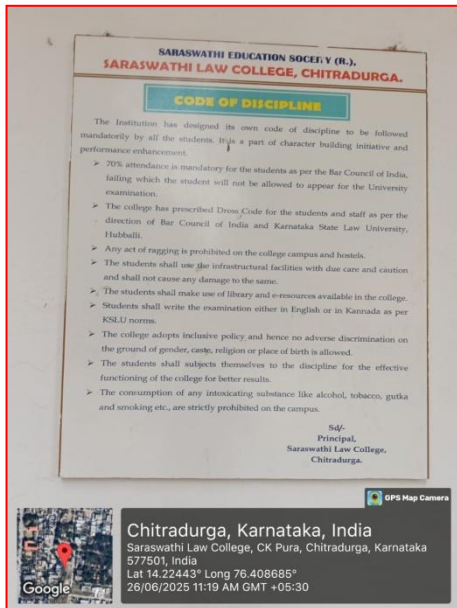
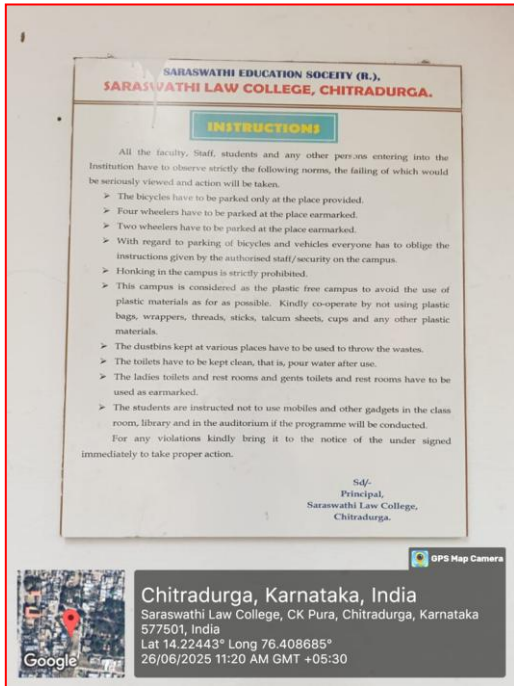
-  The bicycles have to be parked only at the place provided.

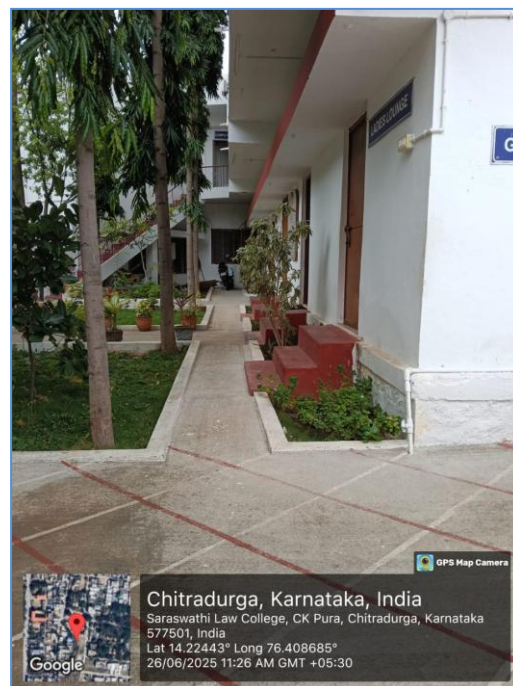
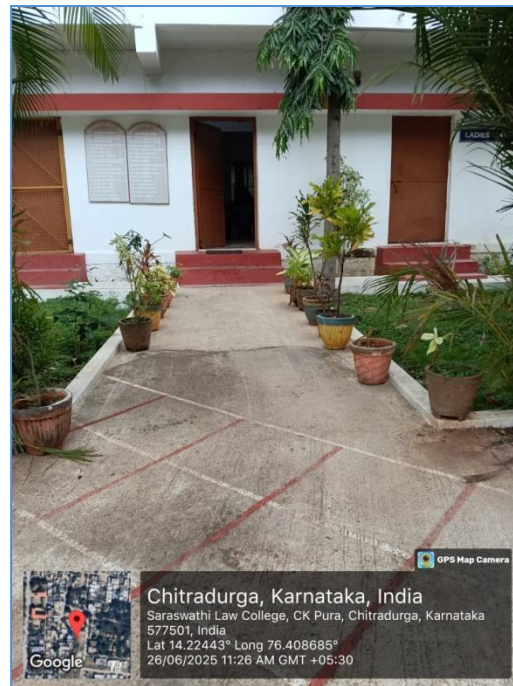
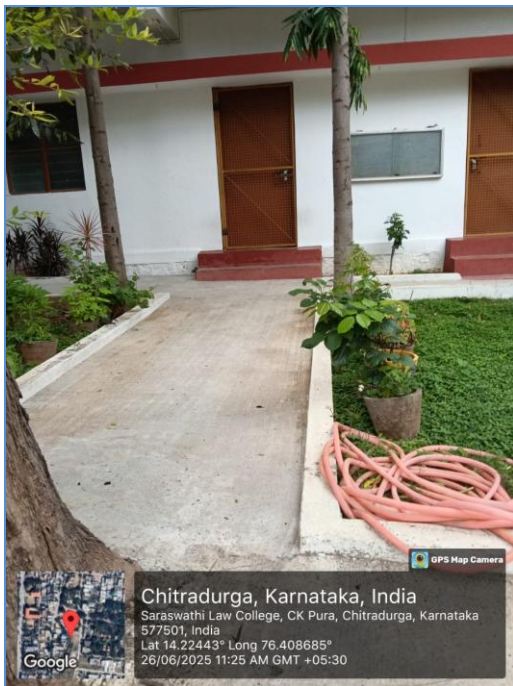
