06	Students requested to adopt higher version of systems in Computer Lab and Library.	We updated our systems in the computer Lab and provided Wi-Fi facility to all Computers during college hours from 9.00 am to 6 pm and also E-Library facilities are provided in Library by adding few more Computers.
07	Students requested for the extension of reading room facilities in the Library.	Two more reading rooms are equipped with furniture's and sufficient space is provided to students. Now more than 100 students can utilise at a time all reading rooms.

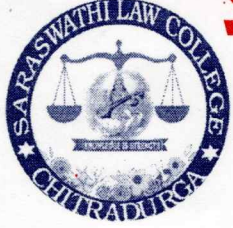
ACTION TAKEN REPORT ON STUDENT FEEDBACK FOR THE YEAR-2024-25
