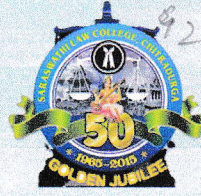

\* The method of choosing the student law forum members shall be through in-formal election or unanimously.

\* If the dispute arises among students for the posts then the faculty will select the members unanimously.

\* The members once chosen shall continue to hold the post till the end of the academic year or until a new member assumes charge whichever is later.

The Student Law Forum shall be under strict supervision and continuous consultation of the faculty of the College.

Any dispute arising regarding the functioning of student law forum shall be resolved by faculty; in consultation with principal and Administration.

## Power and Responsibilities of Student Law Forum :-

To manage all affairs of student's law forum to incur and meet all necessary expenses and do all such acts as are not inconsistent with these rules.

To hold meeting of the Committee at least thrice in a term of when deemed necessary.

To make necessary amendments to the bye-laws prescribed in this Constitution as and when deemed necessary.

To Periodically check the registers and other records.

To implement all decisions taken by the Student Law Forum.

The forum has the authority to plan and conduct guest lectures on legal topics, seminars, debates and cultural events.

To oversee the allocation of funds for forum related events, with accountability to the college authorities.

If Student Law Forum members failed to attend two-three consecutive meetings without reasonable reasons they shall be removed

Prior notice.

These terms apply to all students committed to the student law forum.

Student Law Forum and activities should be primarily focused on providing development, opportunities, representation and recreational activities for students.

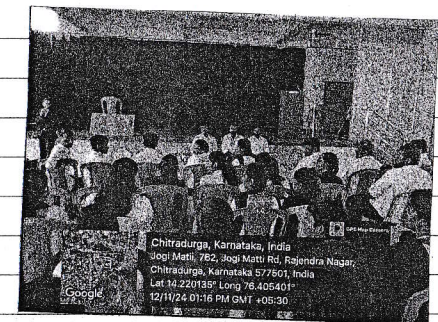
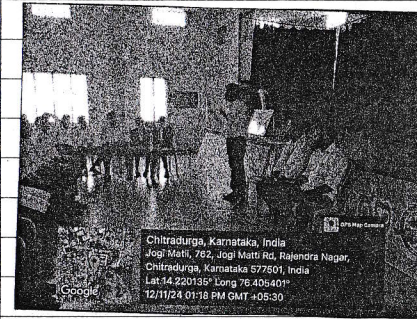

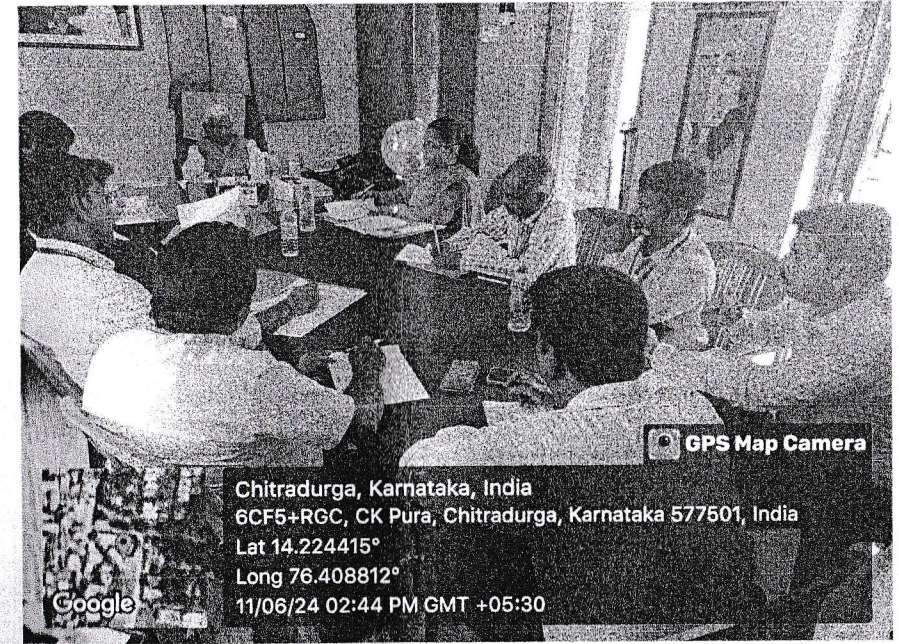

The meeting concluded by delivering Vote of thanks.

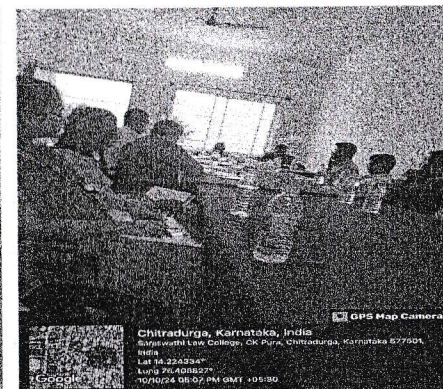
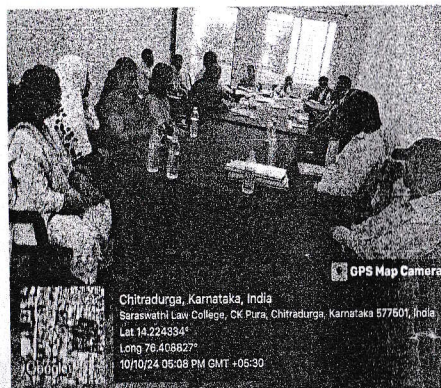
